Louise Wilhelm – Parkersburg City District (2009).

On this date, the County Commission, upon a motion duly made, seconded and passed, approved Erroneous Assessment Applications in regard to personal property for Lewis W. Hanlon – Vienna District (2009); Lori Zornes – Slate District (2009); Matthew C. DeBarr – Clay District (2009); . Spencer – Vienna District (2009); Donald W. Bretz – Parkersburg City District (2009); Ira T. Stone – Slate District (2009) and Christopher DePuy – Williamstown District (2009).

At 10:30 A.M., the County Commission met with Dave White to interview for a position on the Wood County Parks and Recreation Commission (Mountwood Park).

At 10:45 A.M., the County Commission met with Ross Henry Elson to interview for a position on the Wood County Parks and Recreation Commission (Mountwood Park).

The County Commission of Wood County, upon a motion made by David Blair Couch, seconded by Wayne Rick, and made unanimous by Rick Modesitt, placed Dave White and Henry Elson in nomination to fill vacancies that exist on the Wood County Parks and Recreation Commission (Mountwood Park). Said vacancies are due to the fact that Scott Stephens announced his resignation and James Reed's resignation had been previously announced.
