On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission, upon a motion duly made, seconded and passed, approved Erroneous Assessment Applications in regard to real property for Alma Leta Buchanan – Tygart District (2009); William and Sandra Yoho- Tygart District (four for 2009); William G. Yoho – Tygart District (2009); James P. Keith – Tygart District (2009); Malcom and Sylvia Greathouse – Tygart District (2009); Michael Staats – Tygart District (three for 2009); James & Sherry Keith – Tygart District (2009); Amanda R. Richards – Clay District (2007, 2008 and 2009); Nancy J. Thomas – Williams District (2008 & 2009); WV Land Agency -Parkersburg City District (2008 & 2009); Joan D. Brookover – Vienna District (2006, 2007, 2008 & 2009) and Charles L. Brookover – Vienna District (2005);

On this date, the County Commission, upon a motion duly made, seconded and passed, approved Erroneous Assessment Applications in regard to personal property for Brian Poling – Lubeck District (2009); Lawrence H. At 10:30 A.M., the County Commission met with John Reed, Compliance Officer and Bill Brown, County Engineer to report on the Grandview Trailer Park which was under a thirty day cleanup order by the Commission. Tim Miller from the Mid-Ohio Valley Health was in attendance. Property owner, Don Hohman addressed the Commission regarding the progress that has been made over the last month. The County Commission of Wood County, upon a motion made by David Blair Couch, seconded by Rick Modesitt and passed, did hereby ORDER Don Hohman cleanup Grandview Trailer Court located at Gihon Road, Parkersburg, West Virginia, within Upon recommendation of John Reed, Wood County Compliance thirty (30) days. Officer, said property is found to be in violation of The Abandoned and Dilapidated Building Ordinance for Wood County. Mr. Hohman is hereby ORDERED to remove debris, cap open sewer lines and make substantial progress in cleaning up the property. It is further ORDERED that any critical issues with the Trailer Park, as identified by Wood County Engineer, Bill Brown must be addressed within a three (3) day period. Failure of Mr. Hohman to comply with this order may result in the County Commission taking action to bring said property into compliance with the Ordinance.
