

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD
THURSDAY, SEPTEMBER 10, 2009

PRESENT: RICK MODESITT, PRESIDENT

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

At 9:56 A.M., Dick Wittberg from the Mid-Ohio Valley Health Department reported to the Commission on the H1N1 (swine flu) outbreak. He stated they are currently addressing several programs for immunizations for targeted age groups and demographic groups. He stated once the initial groups have been immunized, they intend to offer the immunizations to the general public. He stated their goal is to offer the immunizations early in December, 2009.

At 10:10 A.M., Jamie Six, Wood County Clerk; Walt Auvil, Chairman of the Wood County Democrat Party; Bev Lockhart, Chairperson of the Wood County Republican Party and Melody Ross from the Voter's Registration Office met with the Commission to discuss the possibility of satellite voting precincts for the election cycles. Mr. Six stated the law has changed to allow the satellite precincts to operate a minimum of three days. It was previously set at a twenty day minimum. Following lengthy discussion, it was decided that the two party chairs would go back to their committees and get some direction from them.

At 10:45 A.M., the County Commission met with Jason Wharton, Prosecuting Attorney who discussed the possibility of Sean Andrews serving on the Wood County Civil Service Commission for Deputy Sheriffs. He stated it was a gray area if he could serve since he is a member of the Wood County Recreation Commission.

The County Commission of Wood County, upon a motion made by Wayne Dunn, seconded by David Blair Couch and made unanimous by Rick Modesitt, appointed Sean Andrews to the Wood County Civil Service Commission for Deputy Sheriffs. Said appointment is due to the fact that Greg Smith can no longer serve due to the fact he serves on the Wood County Republican Executive Committee and verbally resigned by calling Marty Seufer, County Administrator. Said vacancy is pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Authorities. Mr. Andrews' term will expire June 30, 2013. An Order was prepared regarding this matter.

At 10:50 A.M., the County Commission met with Clint Pifer with C.L. Pifer and Associates who reported on the possible costs of performing a trail study on behalf of the Commission. He presented the Commission with a proposed contract.

At 11:00 A.M., the County Commission of Wood County, opened sealed bids for the cleanup of property owned by Betty Akers, at 396 Meadville Road, Davisville, West Virginia. Such sealed bids were received pursuant to a LEGAL NOTICE appearing in both local newspapers, The Parkersburg News and The Parkersburg Sentinel, on August 24, 2009 and August 31, 2009. At 11:30 A.M., the County Commission held a hearing in regard to the Emma Tallman estate. After testimony, Fred Tallman was removed as Administrator and James Tallman was appointed Administrator D.B.N with a bond of \$90,000.00. The Order and further information on this estate is on file in the Probate Office.

At 11:59 o'clock A.M., in Room 203, of the Wood County Courthouse, Parkersburg, West Virginia, upon motion of Rick Modesitt seconded by Wayne Dunn and made unanimous by David Blair Couch, County Commissioners, upon prior adjournment of the regular session convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Sections 4, as amended: WHEREUPON, the said David Blair Couch, one of the Commissioners, Rick Modesitt, President of said Commission, and Wayne Dunn, Commissioner met with Marty Seufer, County Administrator and James Cochran with RCDI. All those present proceeded to discuss the matter for which the said EXECUTIVE SESSION was had, being covered by the West Virginia Code Chapter 6, Article 9A-4 of 1931, section (9). The Commission having concluded said discussion, the said EXECUTIVE SESSION adjourned at 1:00 o'clock P.M. An Order was prepared regarding this matter.


Having no further scheduled appointments or business to attend to, the County Commission adjourned.


