At 10:36 A.M., Ron Salter and Bob Hall from Salter and Associates met with the County Commission to discuss the new county brochure. They asked the County Commission to review the brochure for content corrections and advise them of any changes that will need to be made. They mentioned they have removed names of the elected officials so the brochure will remain current.

At 11:02 A.M., the County Commission opened sealed bids for vehicles to be utilized by the Wood County Sheriff's Department. The bids were taken under advisement. (Order M/1267)

At 11:20 A.M., the County Commission called Maryann Hollis, Director of the Humane Society, to discuss how the invoices are being calculated for services being performed within the city limits of the Parkersburg. The County Commission asked Ms. Hollis to schedule an appearance before them in January, 2011 to discuss the contract with the County prior to the Commission adopting their 2011/2012 fiscal year budget.

At 11:38 A.M., Jim Cox from the Lubeck Public Service District met with the County Commission to advise them that the Wadesville project is proceeding and they believe it will start in late February. He also went over other programs they are currently working on.




Having no further scheduled appointments or business to attend to, the County Commission
