It appearing to this Board of Canvassers that the challenged ballots, in the various precincts, were properly made, the challenges either overruled or sustained, and other changes in the tabulation of voters were altered, the canvass is complete, as required by law, and the Commission, upon a motion made by Wayne Dunn, seconded by David Blair Couch and passed, do hereby declare the election results. The

Commission, upon a motion made by David Blair Couch, seconded by Wayne Dunn and passed, recessed as the Board of Canvassers until Thursday, May 20, 2010, at 9:30 A.M. at which time they will certify the results of said election. Anyone requesting a recount will need to submit a three hundred dollar (\$300.00) bond. An Order was prepared regarding this matter.



An Order was prepared regarding this matter.

The County Commission of Wood County, was in RECEIPT of a check from the State of West Virginia for the 2008 Happy Valley Flood Mitigation Program. Said check was in the amount of nineteen thousand six hundred ninety-one dollars and ninety-five cents (\$19,691.95). Receipt of the aforementioned check is pursuant to an Order appearing in Order Book 69 at Page 87 and bearing the date of December 3, 2009. Documentation regarding The 2008 Happy Valley Flood Mitigation Project is on file in the Office of the County Administrator. An Order was prepared regarding this matter.


Having no further scheduled appointments or business to attend to, the County Commission adjourned.


