At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

Agenda and Discussion Items:

At 10:18 A.M., Margaret Pool, Shirley Hunt and Judith Townsend were sworn in as Reserve Deputies with the Wood County Sheriff's Department for the Project Lifesaver Program. Don Daugherty, Chief Deputy and Sue Patalano, Director of Project Lifesaver, were in attendance.

At 10:30 A.M., Jodi Smith from the West Virginia University Extension Office met with the Commission to discuss the Energy Express Program. She stated the \$1,200.00 donated from the County Commission last year was put to good use and was stretched to the last penny. She stated they would like to ask for a donation of \$2,000.00 to \$2,500.00 this coming year. The County Commission approved the donation. (Order M/1189)

At 10:45 A.M., Fred Rader from the Mid-Ohio Valley Regional Council met with the County Commission to discuss the Happy Valley Flood Mitigation program. He stated five of the seven property owners accepted the Commission's proposal and two people declined the offer. Mr. Rader also presented the application for Phase IV of the project. (Order M/1191)

At 11:00 A.M., Randy Flinn and other representatives from Life Ambulance met with the County Commission to request backup status in the County for ambulatory services. Commissioner Couch stepped out of the room due to a possible conflict on the subject because his spouse is

employed by Camden-Clark Memorial Hospital, who provides the same service to the County residents. Representatives from Camden Clark and St. Joseph's Ambulance Services were in attendance. The group will meet with Randy Lowe, 911 Director, (who was present) to further discuss this matter and Mr. Lowe will report back to the County Commission.




Having no further scheduled appointments or business to attend to, the County Commission adjourned.
