At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

Agenda and Discussion Items:

At 10:30 A.M., the County Commission awarded the bid for the new Wood County Justice Center. Sheriff Jeff Sandy and Magistrate Donna Jackson were in attendance and spoke in favor of the Center. (Order M/1218)

Attorney Dan Marshall, Attorney John Stump and Greg Isaacs, bond counsel, met with the County Commission to discuss the bonding amount.

At 11:00 A.M., the County Commission held a hearing in regard to the Jerry Snodgrass estate Charlene Deem, Pam Raubenstrauch, Michelle Snodgrass, Tim Snodgrass and his attorney, William Merriman and Brenda Morris (Sheriff's Tax Office). After testimony, the County Commission Ordered that Timothy Snodgrass be removed as Administrator D.B.N. and Sheriff Jeff Sandy be appointed with no bond. This estate is referred to Vance Golden, Fiduciary Commissioner. Information in regard to this estate is on file in the Probate Office.

At 11:14 A.M., the County Commission reconvened with the bond counsels and attorneys to discuss the bonding amount. A discussion followed and Attorney John Stump stated he will come up

with a figure. An agenda item for setting the bond amount was scheduled for November 29, 2010 at 10:00 A.M.

At 11:30 A.M., the County Commission met with Steve Nicely from the Parkersburg/Wood County Convention and Visitors Bureau to present their new historic guide.

At 12:20 P.M., the County Commission met with Danny Haught from the West Virginia Division of Environmental Protection presented the Commission with the 2010 REAP initiative award.


Having no further scheduled appointments or business to attend to, the County Commission adjourned.
