At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

At 10:00 A.M., the County Commission met with Dan Marshall, Attorney, to discuss the bond amount for the new Wood County Justice Center. The amount of \$6,357,888.50, plus additional cost for the issuance of the bond, was set. (Order M/1226)

At 10:30 A.M., the County Commission met with Ricky Yeager and Attorney Rob Tebay to present an annexation request. (Copy attached)

At 11:00 A.M., the County Commission held a hearing in regard to the Jack Casto estate. Rob Tebay, Attorney and Jack Casto, Jr., and Carl Hostler were present. After testimony, the County Commission ordered that Jack Casto, Jr. be removed as Administrator C.T.A. The County Commission appointed Jeff Sandy, Sheriff as Administrator C.T.A.D.B.N with no bond. Information in regard to this estate is on file in the Probate Office.

At 11:30 A.M., the County Commission met with Fred Rader and Tim Meeks from the Mid-Ohio Valley Regional Council. They were requesting approval of a Drawdown for the Happy Valley Flood Mitigation Project. Said Drawdown is in the amount of \$873,739.65 and was signed by David Blair Couch. (M/1227)

At approximately 11:45 A.M., the County Commission toured the Wood County Justice Center.




Having no further scheduled appointments or business to attend to, the County Commission adjourned.
