At 10:50 A.M., a discussion was held with Wood County Clerk Jamie Six regarding the requirement of 1099 IRS forms being possibly issued to employees with County vehicles.

At 11:08 A.M., Fred Rader and Tim Meeks from the Mid-Ohio Valley Regional Council along with Wood County Compliance Officer Ed Hupp met with the County Commission to discuss the procurement of an asbestos inspector for the Happy Valley Flood Mitigation project. Mr. Meeks stated that eight firms submitted proposals and they have reduced the list to three companies that qualified. The Commission awarded the contract to Jackson Dynamics from Fairmont, WV.
