

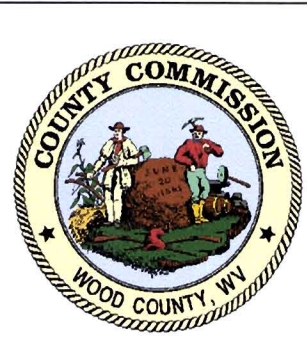


Mr. Pifer will be filling the unexpired term of Mr. Cain which will expire December 31, 2012.
