At 9:38 A.M., Parkersburg Mayor Bob Newell met with the Commission to discuss the Humane Society. The Mayor asked the Commissioners individually to commit to not pursuing legal

action against the City of Parkersburg if they continue to collect the dog tax fee. Commissioner Gainer stated that he will not vote to take the City to court. Commissioners Dunn and Couch stated they intended to leave all options open in the future, but have not discussed the issue since they received the letter last week from the Mayor regarding the fee. Commissioner Couch stated that they will send the City a letter signed by all three Commissioners.

At 10:09 A.M., Attorney Blaine Myers met with the Commission to discuss Meldahl Subdivision and the recent decision to revoke the performance bonds. It was the opinion of Mr. Myers that the Commission rescind the order revoking the bonds and accept the original agreement and the \$3,000.00 check from Lewis Mitchell. The Commissioners stated they will visit Meldahl Subdivision in the near future and revisit the issue.

At 10:30 A.M., Ted Daugherty from the Golf Club of West Virginia requested a variance to the Video Lottery Ordinance. Three residents were in attendance to oppose the variance. 
