Because the property was owned by the State, not tax ticketed was issued for 2011. This will force Mr. Curry to pay a penalty for 2011 since no ticket will be able to be generated until 2012. The County Commission

asked the Assessor to present an exoneration which they will sign authorizing an assessment on the building, thus allowing Mr. Curry to pay the taxes.
