Gentlemen:

Due to Mike Davis, our current after-hours security bailiff being made a full-time bailiff, he is unable to provide us with after-hours security for both Monday and Wednesday nights. For this reason, I am asking the Commission to approve the hiring of Mr. Ed Layton, another part-time bailiff to help share the work with Mr. Davis. They will each work one night a week for a total of 3 hours each, and on occasion will fill in for each other so that on some weeks one of them may work up to a maximum of 6 hours a week. At no time will either security person work any more than 6 hours in any given week. We have the funds in our budget to pay for this position. Mr. Layton has been through the necessary bailiff training and is certified. I appreciate the Commission's attention in this matter, and all appropriate background checks have been completed.
