Conclusions of Law

The Commission makes the following Conclusions of Law:

- 1. This estate is insolvent.
- The Administratrix, CTA, has applied the assets of the Probate Estate to payment of debts of the estate in their proper priority of payments as required by West Virginia Code Section 44-2-21.
- 3. All unpaid Proofs of Claim which have been filed but not paid are of inferior priority to the debts of the estate which were paid. Since the estate is insolvent, all unpaid Proofs of Claim should be abated and this estate should be closed without payment or release of filed Proofs of Claims because there are no assets in the probate estate from which to pay said claims.
