The library has already received a quote from Greenleaf Landscaping for upgrading of the sidewalk to make the building handicap accessible. The Clerk's Office will submit the quote to the State to determine if the work qualifies for grant funding through the Secretary of State's Office for ADA Compliance in the precincts. Ms. Ross

informed the County Commission the Library Board has approved the use of the facility as the new precinct. (Order A/969)

At 10:40 A.M., the County Commission met with Larry Butcher who expressed his concern over the property his son owns being cleaned up yesterday.


At 11:05 A.M., the County Commission discussed the possible carryover of funds for the current fiscal year. No decisions were made.
