At 10:15 A.M., the County Commission met with Ann Conageski from the City of Parkersburg to discuss the American Wind Symphony concert on Sunday, July 8, 2012. She was requesting they be permitted to set off fireworks from Fort Boreman Park. The County Commission did not object and agreed they would be permitted to do so.
