Effective September 29, 2012 Amy Boyd resigned as a Case Manager with the Wood County Day Report Center. After reviewing potential candidates, the Day Report Center hired Sherry Wise effective October 9, 2012. (A copy of Ms. Wise resume is attached.)

When Ms. Boyd was employed by the Day Report Center, she was paid \$30,000 per year. However, Ms. Wise will be paid \$34,000 per year based upon her experience, her educational level (Masters Degree), and her certification (Masters Certified Addiction Counselor). The difference in the salary amount and the benefits associated with it will be covered by a reduction in the number of hours worked by Leona Ruth, the current part-time counselor. Ms. Ruth's hours will be decreased from 20 hours/week to 10 hours/week which will result in a savings of \$13,000.
