

The Mid Ohio Valley Air Show committee kindly requests the support and partnership of The Wood County Commissioners in supporting the Mid Ohio Valley Air Show on Sunday, October 14. The Air Show has been a staying community event for 42 years through the efforts of countless volunteers and sponsors such as the McDonough Foundation. The Air Show will continue as a free community event this year with a spectacular line up of performers; the largest Free Aviation Kidz Zone; Park and Ride Shuttle service to and from the event in both West Virginia and Ohio; for use as Shuttle Park and Ride for attendees of the Air Show.

Mid Ohio Valley Air Show will have volunteer personnel help to oversee the parking, load and launch of the shuttles; Kidz Zone, manning of Pepsi stands, assistance in marketing and media; Vendor help and monitoring of crowd need. The air show in turn supports community organizations and groups with disbursement of funds for their participation.

*In addition, the Air Show showcases the County's airport, terminal and facilities; brings economic resources to the community and provides a large revenue to local businesses*

This year the Air Show faces several monetary hurdles that did not present themselves in past shows. First a 40% increase in fuel costs from just two years ago. A drop in military air support to almost nil, and an increase in air performance fees of which the performers we obtained reduced travel costs to assist our show. (see attached budget)

We ask that the Wood County Commissioners to consider a donation commitment of \$50,000.00 in funding the Air Show and supporting the area's largest aviation event.




