This Joint Use Agreement, made this _______, day of ________, 2013, by and between the Wood County Commission and the City of Parkersburg, a municipal corporation.

Whereas the parties are owners of certain hereinafter described real property; and

Whereas each of the parties has a need for certain of the other party's property. Now, Therefore, This Agreement Witnesseth:

That for and in exchange of the respective right to use and occupy each other's hereinafter described real property each party grants and demises to the other the right to use and occupy their respective parcels for and as vehicular parking and as follows:

- A. The County Commission grants and demises the use of the parking spaces but only those spaces immediately adjacent to and bordering upon Avery Street and 3rd Street, in Parkersburg, WV and consisting of the 21 spaces adjacent to Avery Street and the 24 spaces adjacent to 3rd Street as platted and showing on Map survey dated 1/11/2013 attached hereto as Exhibit 1.
- B. The City of Parkersburg grants and demises the use of the parking areas along and adjacent to the northerly and southerly side 2nd Street as and where 2nd Street extends east of Avery Street together with that parking area at the southerly terminus of Avery Street at or near 1st Street attached hereto as Exhibit 2.
 - 1. Purpose. The areas herein demised shall be used for parking.

The parking area so demised shall be kept and maintained by the party to whom the use of such area is herein granted and in such a manner that the area is kept in good condition, both as to appearance and safety, and such maintenance shall be accomplished in such a manner as to cause no unreasonable interference with the use of the adjoining or contiguous street or parking area as the case may be.

Each party shall be required to assume the responsibility for policing and maintaining the areas herein leased to it for the purpose of prohibiting illegal or unauthorized parking upon said area(s).

Further each party shall, at its own expense, obtain and maintain liability insurance coverage and be

otherwise responsible for the parking area assigned them in this agreement.

2. Term.

This agreement is for a term of twenty (20) years from and after the date hereof. In the event the area or areas of such used are abandoned by the party to whom the use is herein granted, or is not used for its intended purpose, this agreement may be cancelled by the granting party who, upon such cancellation may forthwith reenter upon and take possession of such area(s).

3. Assignability

The rights granted in this instrument shall not be transferred, assigned or conveyed to any other person, firm, corporation, or public body without prior approval of the granting party.




