The County Commission authorized President Dunn to execute a Memorandum of Understanding with the Wood County Community Emergency Response Team for radio communications in the event of an emergency.

At 10:00 A.M., Brian Tregoning from Fox Engineering, met with the County Commission to propose them utilizing his services for consulting on Wireless Telecommunications Facilities. Commissioners Dunn and Couch spoke in favor of the service. It was agreed to place on an agenda two weeks out to allow the public to comment to the Commission regarding utilizing their services.



ORDER

The County Commission of Wood County was in receipt of a New Road Name Request Form from Charles McCay, to name the road to his residence AMICALOLA WAY. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. The road to be known as AMICALOLA WAY is located North of Oakwood Estates between Old St. Marys Pike and Doug Lane in Union District, Tax Map 200, Parcel 13. Memorandum of Understanding Wood County Commission Wood County Community Emergency Response Team (WC-CERT)

The Wood County Commission requests that, in the event of a community emergency or disaster or other situation in which the Wood County Office of Emergency Management could request assistance in any area in which Wood County Community Emergency Response Team members have received appropriate training, the WC-CERT respond to meet those needs whenever possible.

Each organization agrees to provide to the other, professional, technical and/or physical assistance. Each organization retains the responsibility and authority to decide on a case-by-case basis their ability to provide such assistance.

In support of this agreement, the Wood County Commission:

- Provide WC-CERT with the use of public safety frequency 155.280, call KAF620, which is licensed for 20 units. The frequency is to be used for radio communications for emergency response and training.
- Provide WC-CERT with recommendations for training.
- Assist WC-CERT in the planning and implementation of training.
- Provide opportunities for WC-CERT to participate in appropriate emergency response drills and exercises.

In support of the agreement, WC-CERT will:

- Utilize the provided radio frequency only as necessary and appropriate. WC-CERT members must abide by FCC regulations. Any misuse of the radio frequency will result in termination of this agreement.
- Use FCC Public Safety approved radios which are narrow banded for the frequency.
- Ensure that WC-CERT members receive appropriate training in radio procedures.
- Provide the Wood County Office of Emergency Management and Wood County 9-1-1 with the names and unit numbers of WC-CERT personnel authorized to use the assigned frequency
- Provide the Wood County Office of Emergency Management and Wood County 9-1-1 with a current contact list of at least six names to initiate a WC-CERT call-out.


