At 9:05 A.M., the County Commission signed a Proclamation in regard to the 200th

anniversary of the death of Governor James Wood. Proclamation is attached.

At 9:07 A.M., the County Commission discussed a request from Steve Parker to from the

Sweet Creek Gathering monies for their fall event. The Commission decided to wait to see if Sweet

Creek gets reimbursed from the State for a Governor's Community Participation grant prior to their

event.

At 9:12 A.M., the County Commission met with Toni Tiano, Grant Consultant, along with Tom

Smith and Captain Rick Woodyard from the Wood County Sheriff's Department. They requested a

grant application for a Port Security Grant to be executed. After discussion, the County Commission

Mr. Miracle then stated they are in line for a Community Participation Grant which should provide them funding to reimburse the County for a loan they made to the group for construction of a limber.

WHEREAS, James Wood served as an officer of the United States Continental Army during the American Revolution; and

WHEREAS, James Wood was a Federalist and was chosen as an elector from Hampshire District of the State of Virginia for the 1789 presidential election; and

WHEREAS, the Hampshire District of the State of Virginia encompassed several counties now included in the State of West Virginia; and

WHEREAS, James Wood served as the eleventh governor of the State of West Virginia from the year 1796 to the year 1799; and

WHEREAS, Wood County, Virginia was formed and created by an act of the Virginia General Assembly passed on December 21, 1798 and named in honor of the sitting governor of Virginia, James Wood, who, thus, is considered to be one of the county's founding fathers.

NOW, THEREFORE, BE IT PROCLAIMED, that the County Commission of Wood County, in commemoration of the 200th anniversary of the death of Governor James Wood, does hereby PROCLAIM that June 17, 2013 is hereby declared as "A Day of Remembrance for James Wood" in Wood County.

Wood County Alternative Transportation System—The Wood County Alternative
Transportation System shall be a countywide system of greenways and trails which shall
consist of individual greenways and trails and networks of greenways and trails which may
be designated as a part of the countywide transportation system by the County
Commission. Mapping or other forms of identification of lands and waterways as suitable
for inclusion in the system of greenways and trails, mapping of ecological characteristics for
any purpose, or development of information for planning purposes shall not constitute
designation. No lands or waterways may be designated as a part of the countywide system
of greenways and trails without the specific written consent of the landowner and/or
manager.

Wood County Alternative Transportation Council; composition; powers and duties. —

- There is created within Wood County, The Wood County Alternative Transportation Council which shall advise the County Commission in the execution of the Council's powers and duties under this chapter. The council shall be composed of twenty members, consisting of:
 - a. Five members appointed by the County Commission, with two members representing the trail user community, two members representing the business community, and one member representing private landowners.
 - b. Eight members appointed, two each by the Mayor of the following municipalities in Wood County:
 - i. Parkersburg
 - ii. Vienna
 - iii. Williamstown
 - iv. North Hills
 - c. One member appointed by the President of WVU-P.
 - d. Two members appointed by the Mid-Ohio Valley Regional Council.
 - e. One member appointed by the WV Department of Transportation.
 - f. One member appointed by WV State Parks.
 - g. One member appointed to represent Wood County Parks.
 - h. One member appointed to represent the Historical community
- 2. The term of all appointees shall be for 2 years. Appointees may be reappointed for no more than four consecutive terms. All appointees shall serve until replaced.
- 3. The duties of the council shall include the following:

- a. Facilitate a countywide system of interconnected landscape linkages, conservation corridors, greenbelts, transportation and recreational corridors and trails, scenic corridors, utilitarian corridors, reserves, regional parks and preserves, ecological sites, and cultural/historic/recreational sites using landbased trails that connect urban, suburban, and rural areas of the county and facilitate creation and expansion of the countywide system of water trails.
- b. Creating, implementing and maintaining a master plan for the Wood County Alternative Transportation System.
- c. Maintain an inventory of the countywide system.
- d. Recommend priorities for critical links in the Wood County Trails System.
- e. Review proposals for inclusion in the Alternative Transportation System.
- f. Encourage public-private partnerships to develop and manage greenways and trails.
- g. Review progress toward meeting established benchmarks and recommend appropriate action.
- h. Promote greenways and trails support organizations.
- i. Support the Wood County Alternative Transportation System through engineering, education, enforcement, encouragement and evaluation.
- 4. The council shall establish procedures for conducting its affairs in execution of the duties and responsibilities stated in this section, which operating procedures shall include determination of a council chair and other appropriate operational guidelines.
- 5. The council shall meet at the call of the chair, or at such times as may be prescribed by its operating procedures. The council may establish committees to conduct the work of the council and the committees may include nonmembers as appropriate.
- 6. A vacancy on the council shall be filled for the remainder of the unexpired term in the same manner as the original appointment. Members whose terms have expired may continue to serve until replaced or reappointed.
- 7. Members of the council may not receive any compensation for their services but are entitled to receive reimbursement for expenses as deemed by the County Commission in advance of the expenditure.

They believe if they receive advice concerning other Humane Societies, then it will help Wood County make a profit. They are working on the budget.
