At 9:00 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices, orders and other correspondence.

The County Commission approved Erroneous Assessment Applications for real and personal property. Copies are attached to these minutes and shall be made a part thereof.

Jonathan R. Casto was sworn in as a Court and Transport Officer for the Wood County Sheriff's Office.

Ed Hupp was sworn in as a member of the Enforcement Agency for the Abandoned Building Ordinance.

The Commission was made aware that David Carrico, Jeff Sandy and Tim Miller should be removed from the Wood County Commission on Crime, Delinquency and Correction. Ken Merritt, Anne Thomas and Dennie Huggins should be added. (Order A/1080)

AGENDA AND DISCUSSION ITEMS

At 9:05 A.M., the County Commission awarded the installation of backflow prevention valves for the Courthouse, Judge Black Annex and the Holmes R. Shaver Annex to Simplex Grinnell LP. (Order M/2292)

At 9:10 A.M., Maryann Hollis from the Mid-Ohio Valley Humane Society, met with the County Commission to request an addendum to their contract with the County for the remainder of this year as well as next year

At 9:30 A.M., the County Commission discussed several items regarding planning:

Renaming the Blennerhassett Bridge, "The Nick Null Memorial Bridge" – Commissioner Dunn stated it may make more sense to push to have the Fifth Street Bridge instead, since it would not require State approval.

Wireless Tower Ordinance with Fox Engineering – After discussion it was generally agreed perhaps it would be best to increase the application fee and continue to perform the process ourselves.

CAP Building – Commissioner Couch stated he would put together a meeting with Airport Manager, Terry Moore, the Health Department and the Civil Air Patrol. Mr. Seufer stated that Bill Brown, County Engineer, planned to attend next Monday's meeting to address this.

Commissioner Dunn discussed the possibility of the Health Department finding a new facility.

The Commission discussed the creation of a return to work policy for the County. Commissioner Couch stated he will provide a model through the West Virginia Risk Pool.

Commissioner Dunn stated he would like to have the Director of Not for Sale Ministries, the organization who the Commission deeded the Latrobe Street property to, come in and let the Commission know what they are doing with the property.

Wood County Day Report Center Director, Dennie Huggins stated he would be willing to serve on the Wood County Senior Citizens Board, but would prefer to wait until later in the year since he is new to the position and had his hands full.

The Commission discussed potential monies owed back to the General Fund from the Day Report Center.

The Commission discussed the shooting range on the south side of Parkersburg. Commissioner Couch stated he advised them to contact the Prosecuting Attorney and the Sheriff as a resolution.

Chief Tax Deputy, Bob Tranquill and employee Jenna Phipps met with the Commission to give them a quote on paper they needed to purchase for the tax tickets they need to print. Mr. Seuffer asked them about the tax office software problem that Ms. Phipps had brought to the Commission's attention. She stated the problem still exists, but they are using a workaround with the printers to address the issue.

Larry Blair addressed the Commission to discuss problems with four wheelers and trucks tearing up a County road in his area and having campfires which are dangerous. The Commission requested Mr. Blair furnish them with copies of any letters written by the Sheriff's Department of the Division of Natural Resources.

The Commission discussed gas wells and mineral fees. Attorney Blaine Myers had advised the Commission they do not have the power to attach a fee to minerals or gasses coming out of the ground. Commissioner Couch stated we should look into putting in a permit fee. Commissioner Dunn stated that Attorney Myers had advised him they would need to address the issue with the State government. Commissioner Couch stated he will contact Mr. Myers for further advice.

Commissioner Dunn asked if anyone had any new ideas to increase revenue. Commissioner Couch stated perhaps we should look at asking the City of Parkersburg to help us out on the Humane Society bill regarding the care of cats.

The Commission discussed purchase orders. Jamie Six, County Clerk, stated he had received a letter from Ritchie County stating they had an Order allowing the Clerk to pay utility bills without prior approval.
