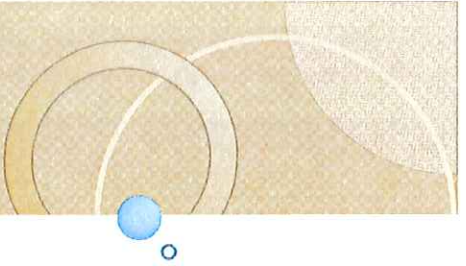

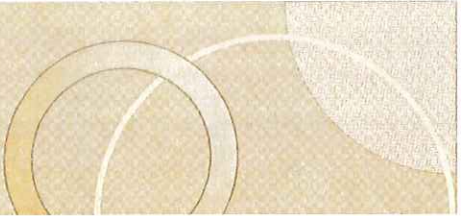
Justification to Support Continued Contract for Building Outside of the Charity Care Dollar Expectation

On January 1st, 2014, the Affordable Care Act was initiated. Many people previously considered “Charity Care” are now eligible for Medicaid reimbursement for services. This shifts the money to the federal Medicaid program from the state general revenue fund. In comparison to last year, Westbrook has seen 300 more clients, in comparison, we have provided services to 700 more Medicaid recipients than last year.

January-June 2014 – 56% of referrals were Medicaid

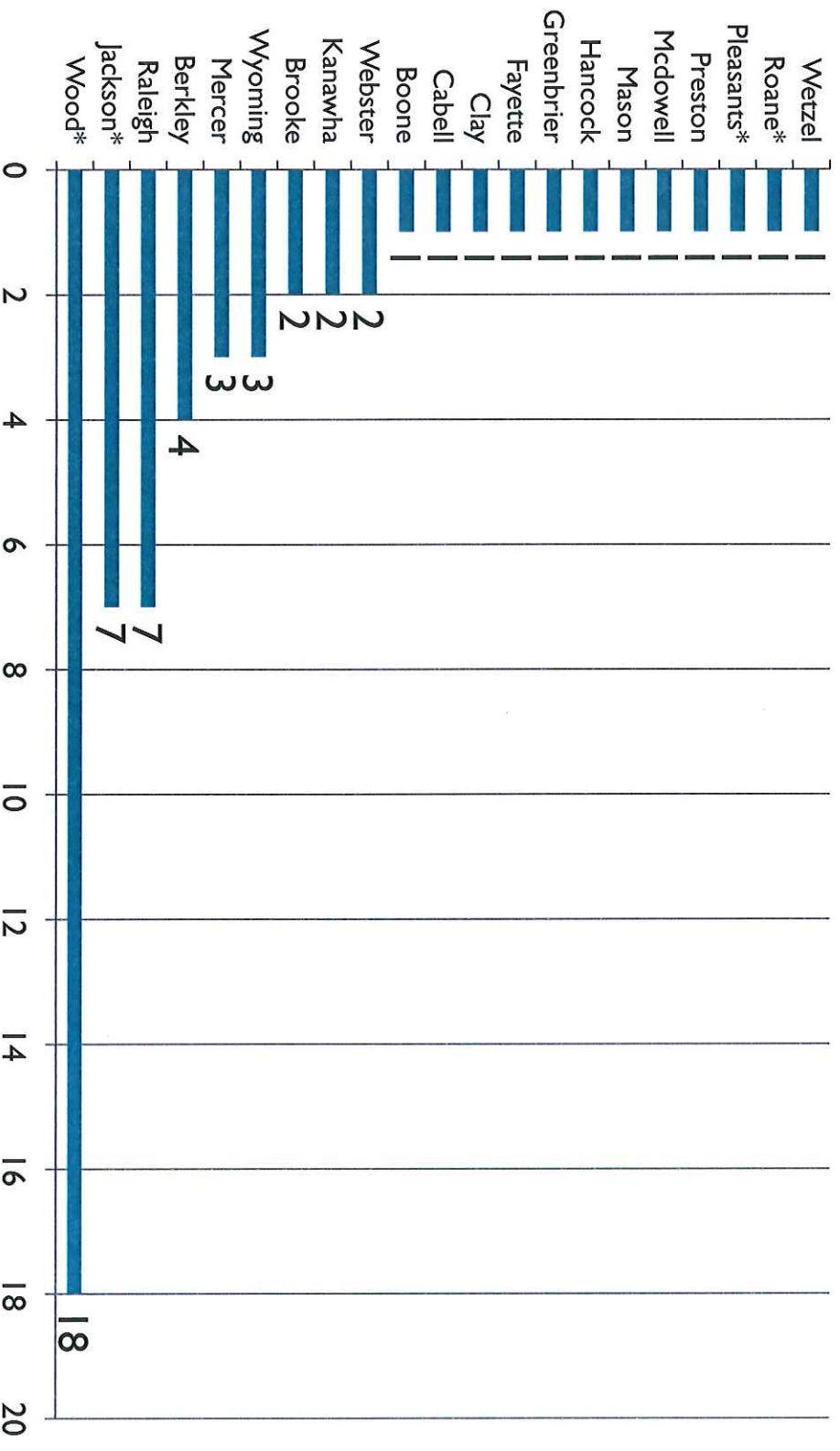

Amity Detox & Treatment Center 60 Total Admissions, by County

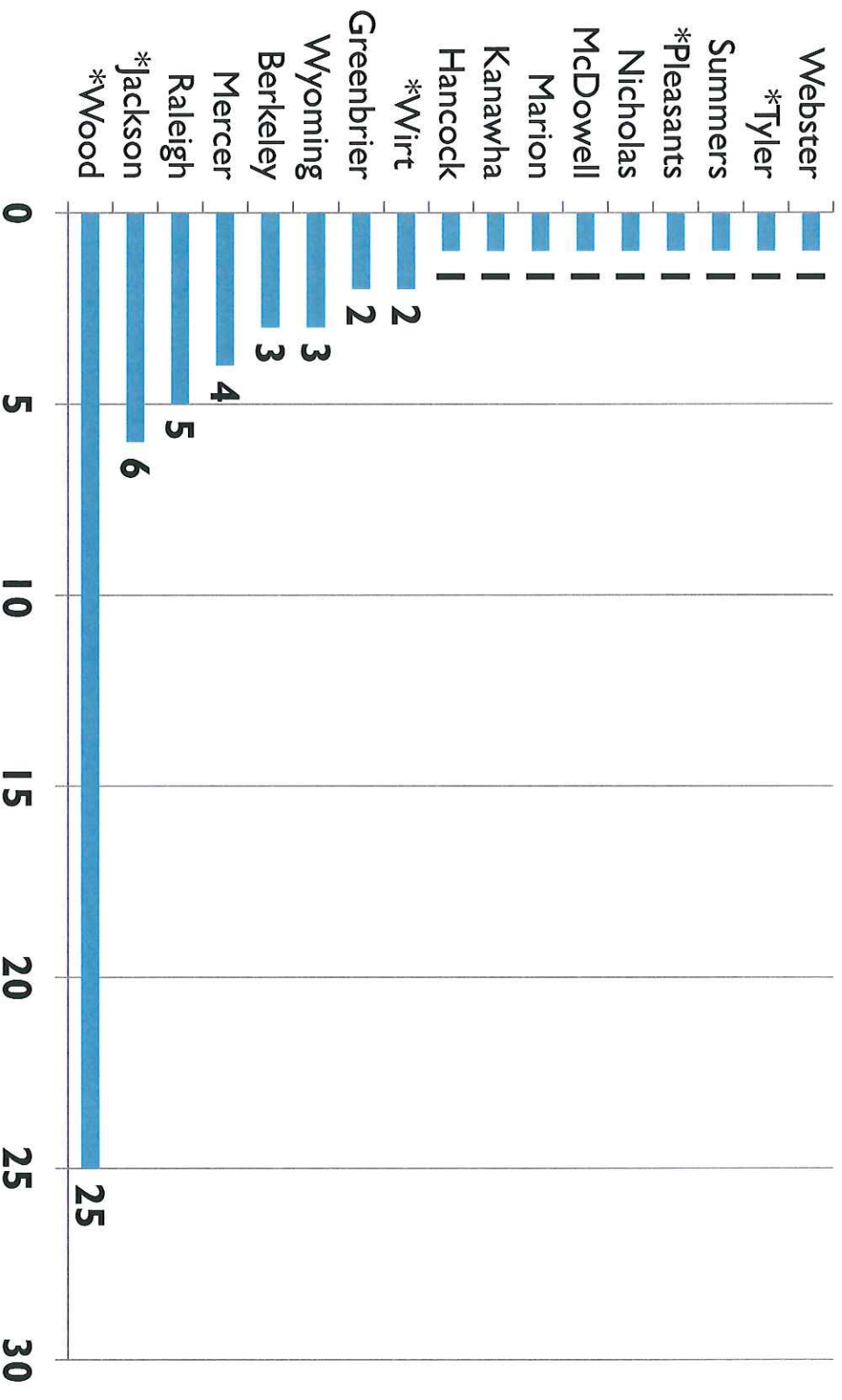
2nd Quarter 2014

Amity Detox & Treatment Center 59 Total Admissions, by County

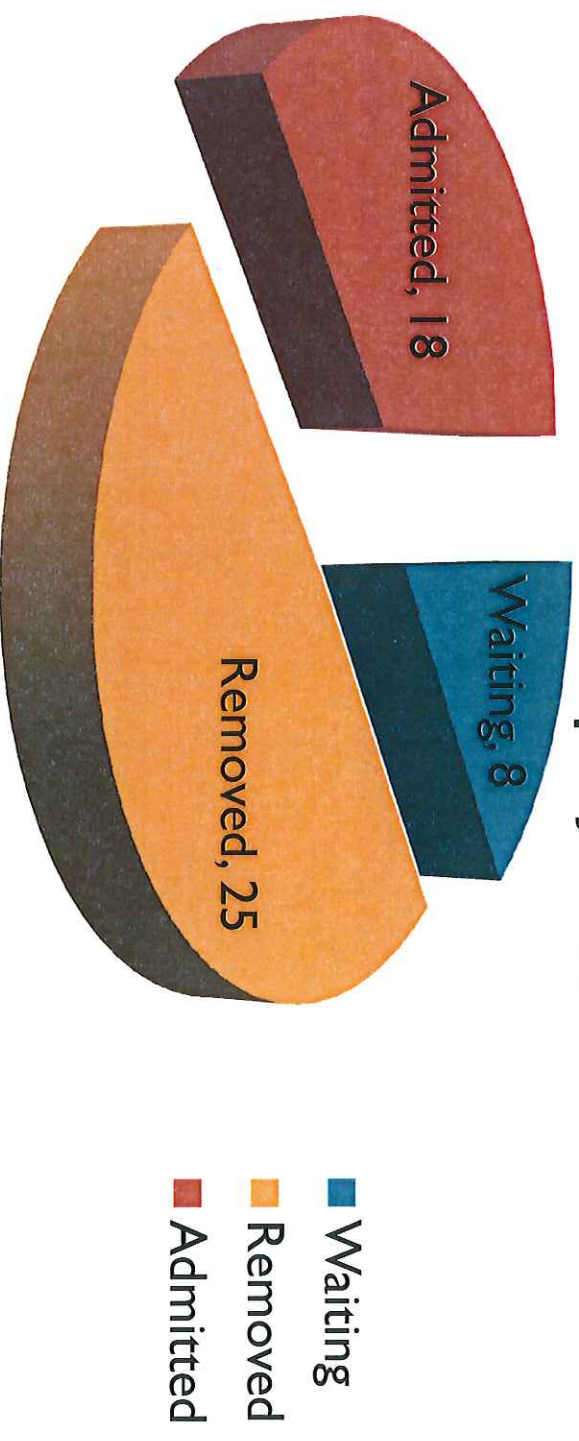
1st Quarter 2014

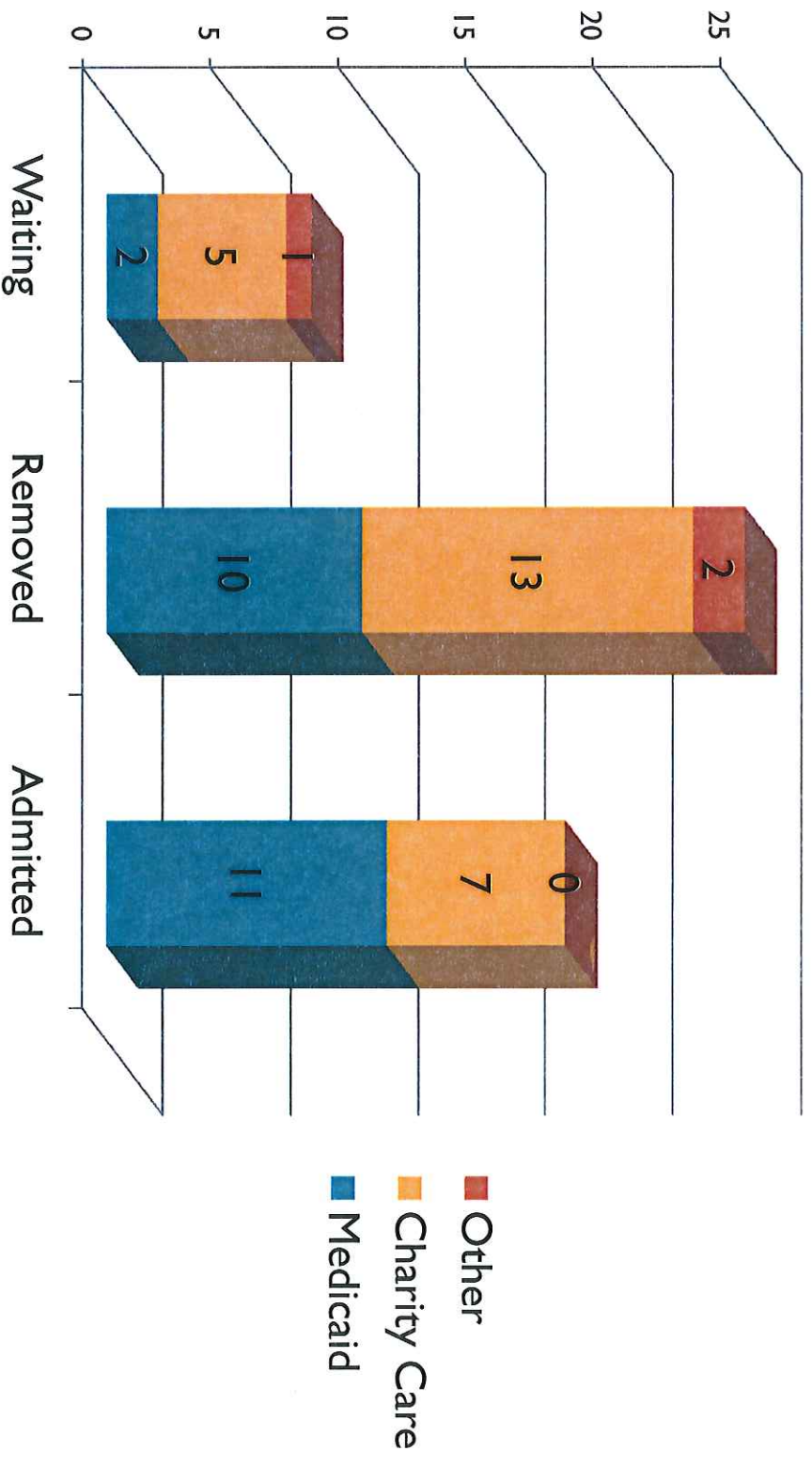

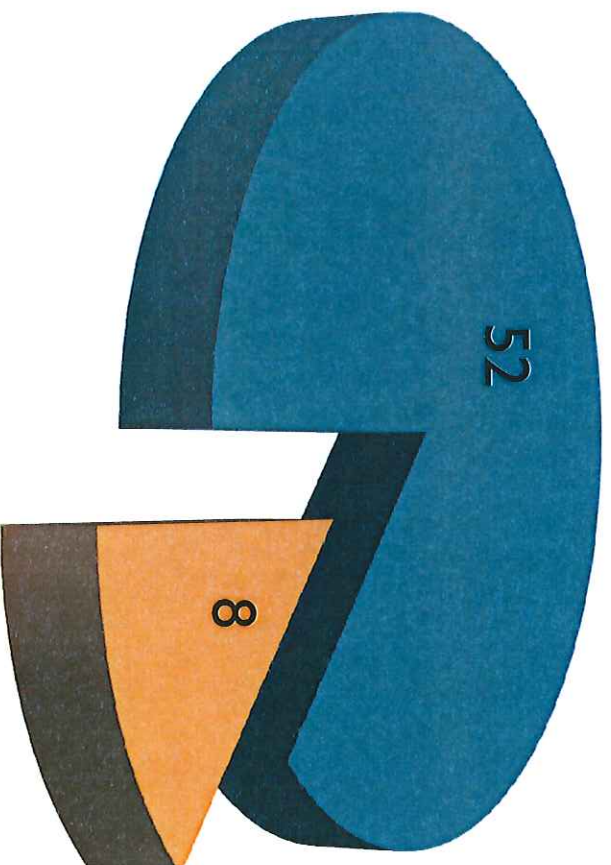
Amity Detox & Treatment Center

2nd Quarter 2014 – Funding Source

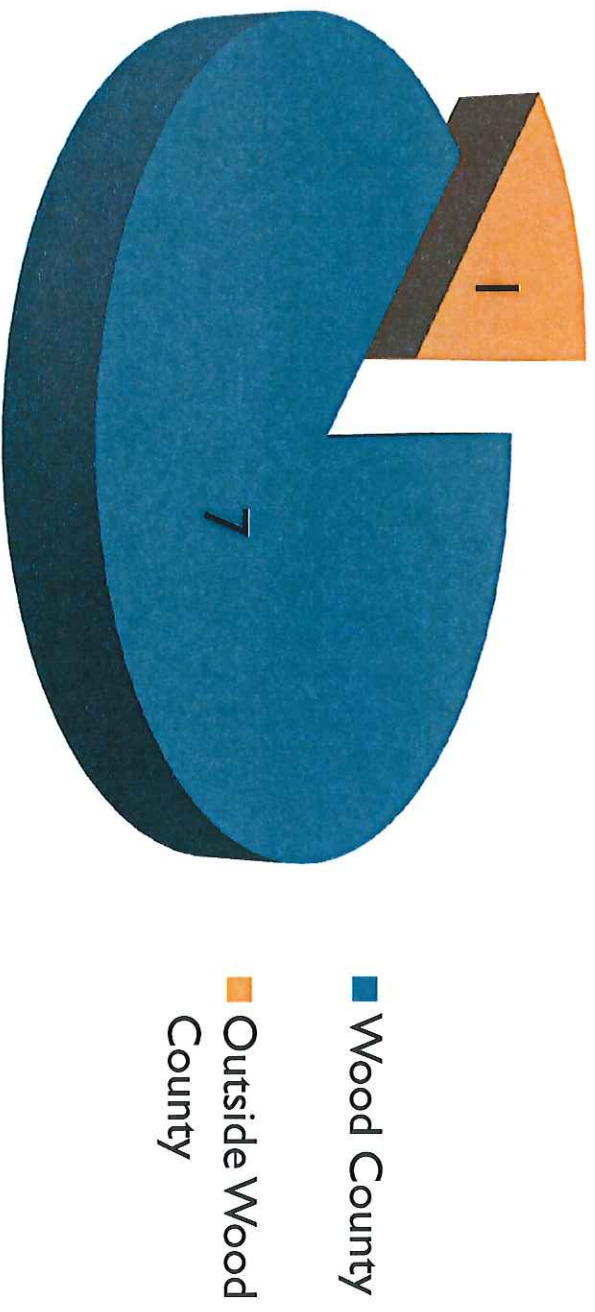


Amity Detox & Treatment Center Funding Source Totals for Admissions for the State 2nd Quarter 2014

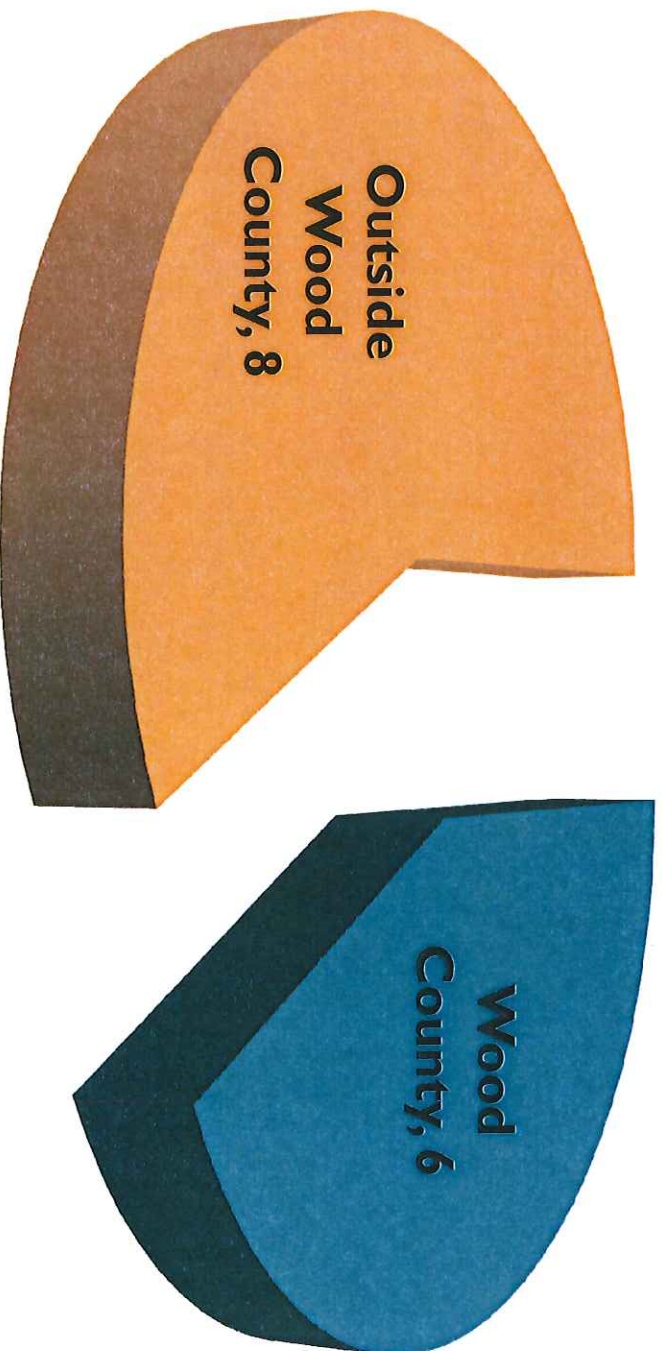

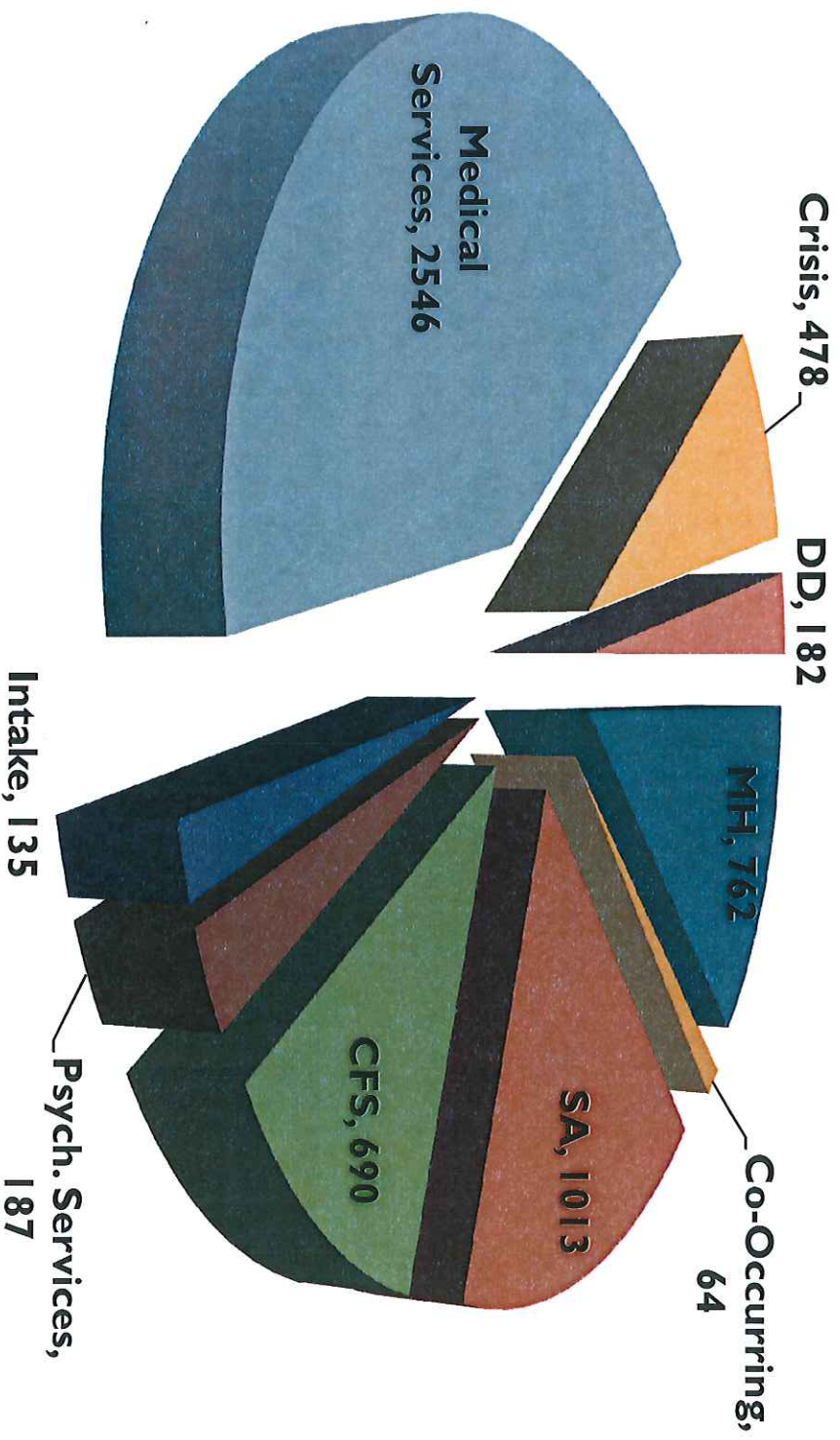

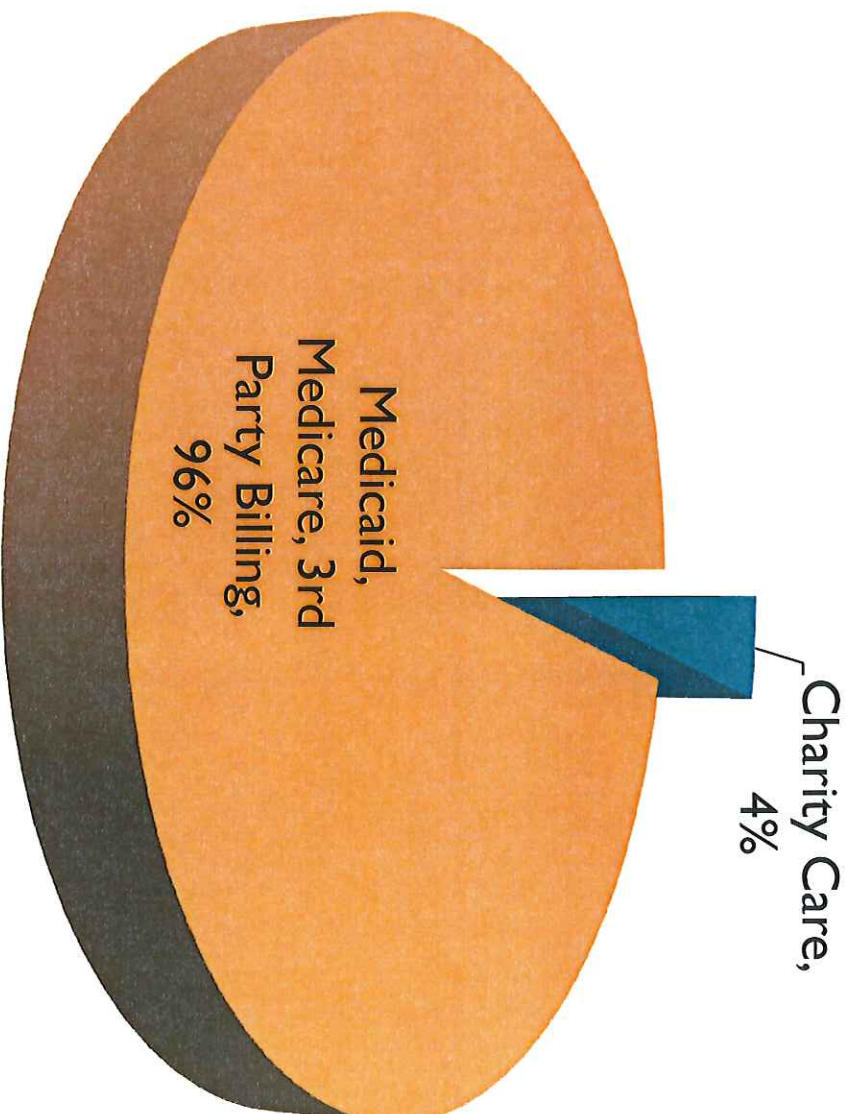

Wood County Funding Sources

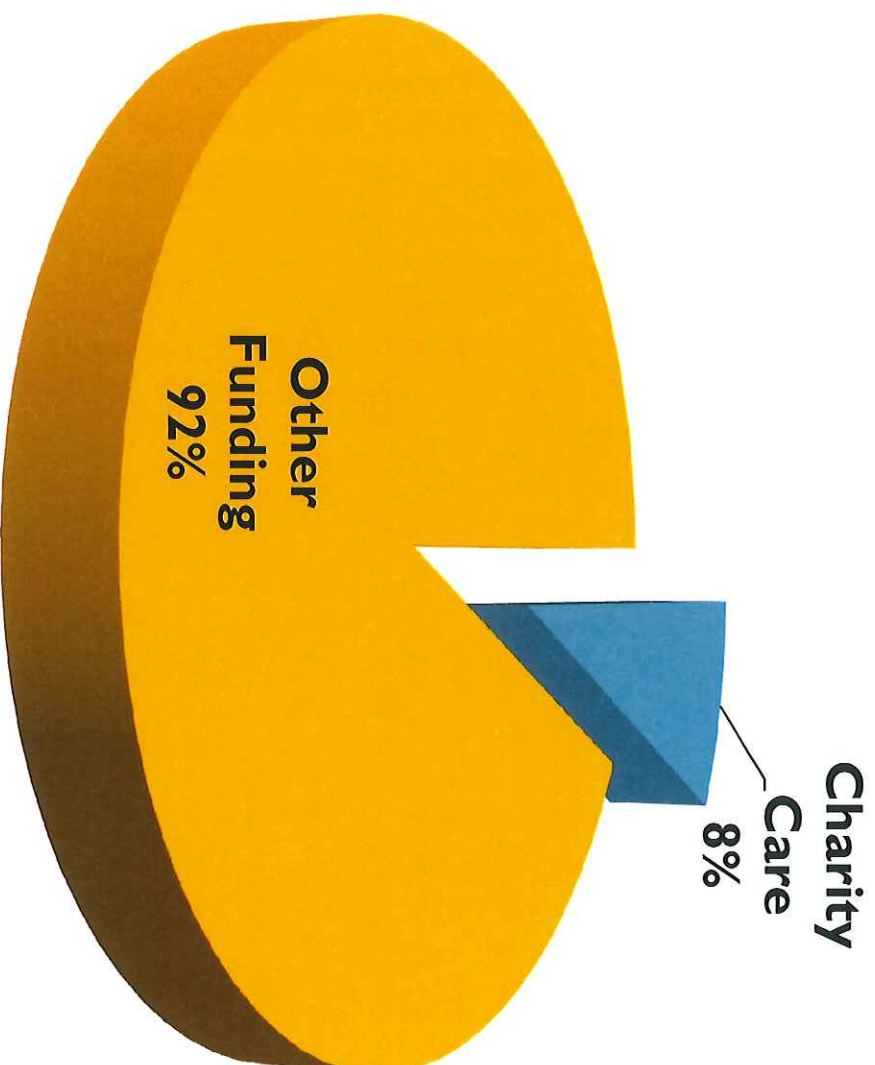

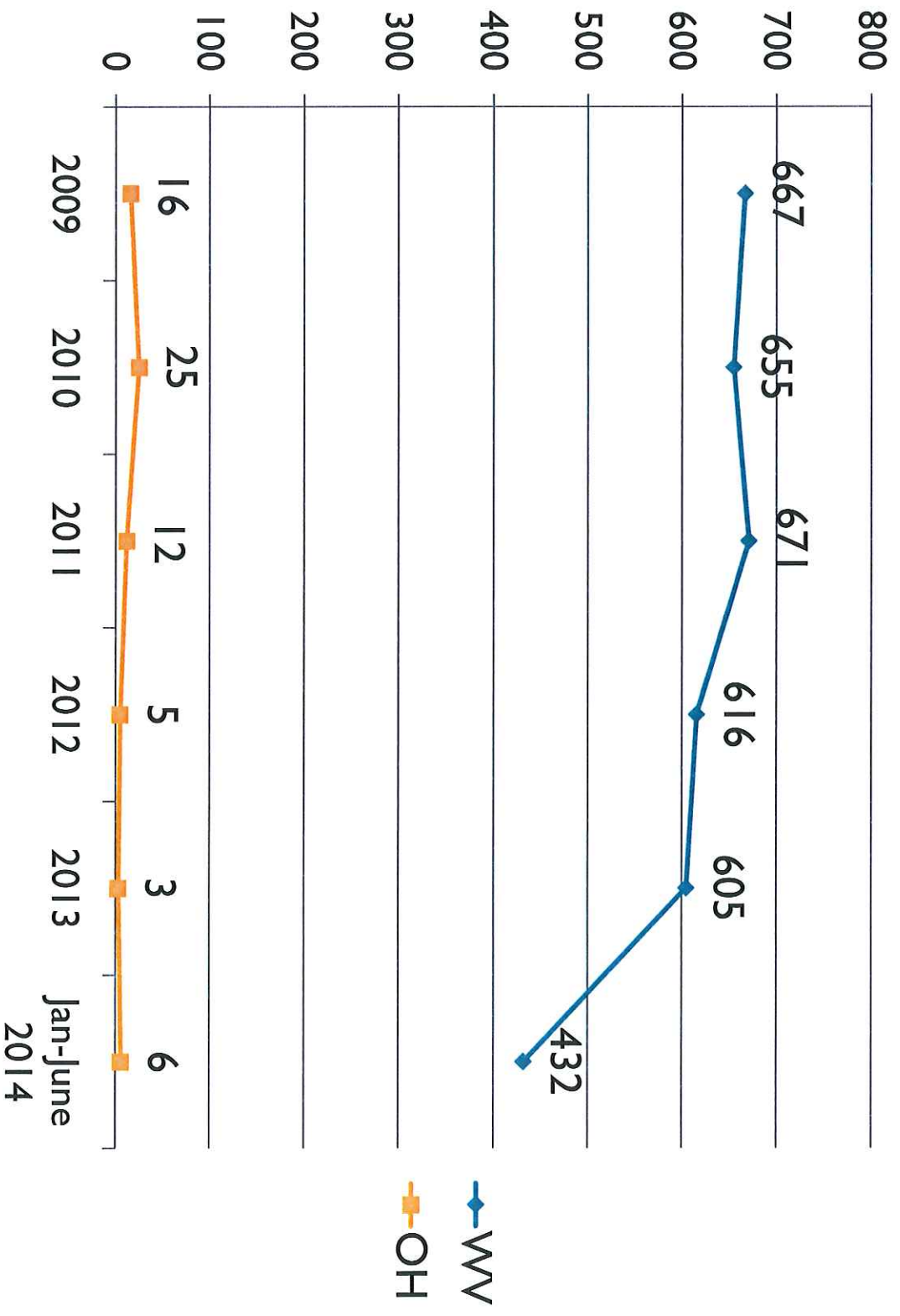

1st Quarter 2014



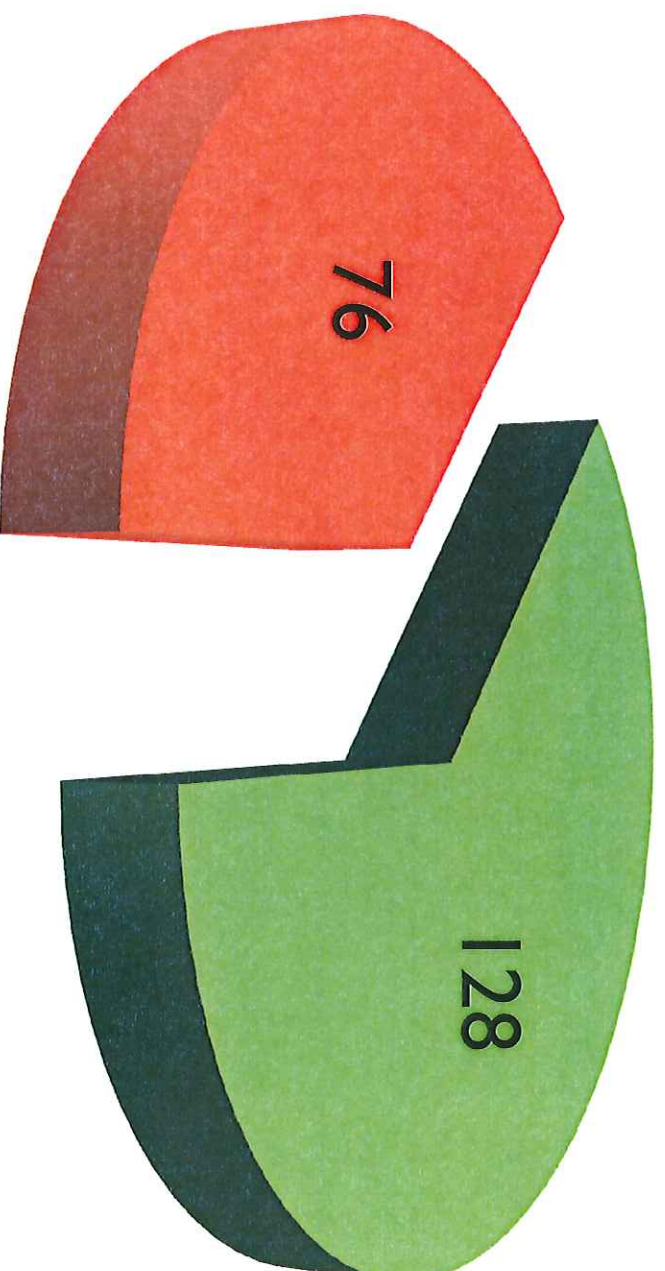

Total Face to Face Contacts – 628

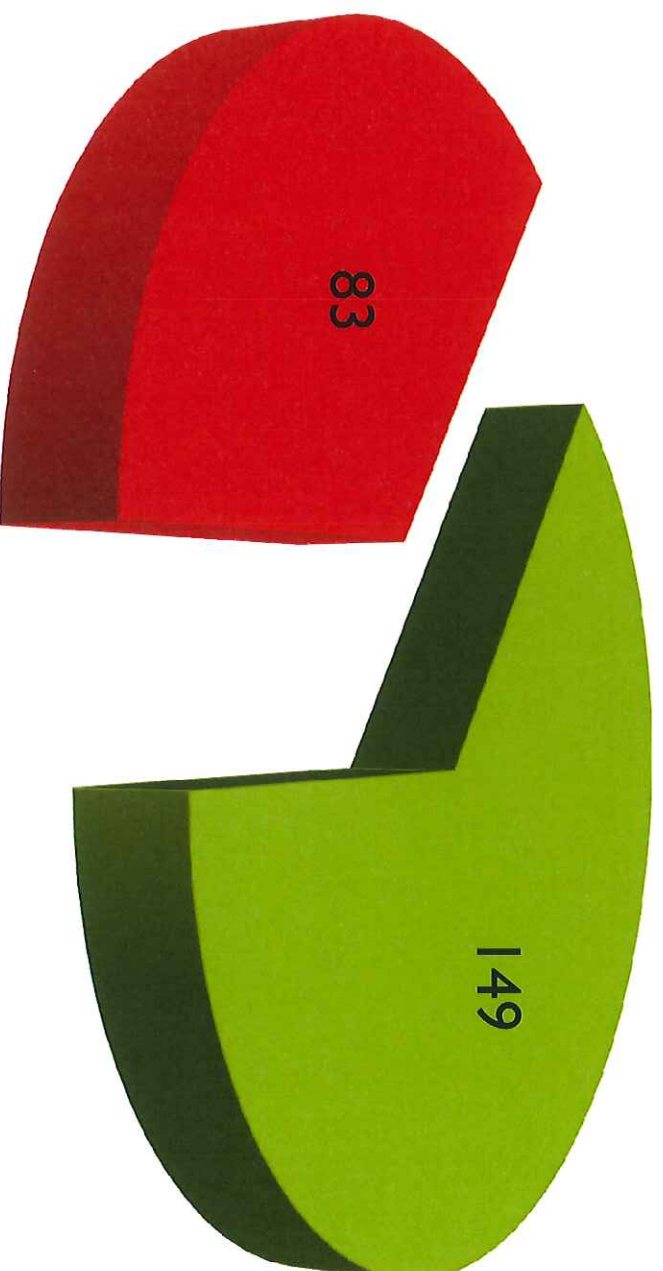
