



# Amity Detox & Treatment Center 59 Total Admissions, by County












### Wood County Statistics 2<sup>nd</sup> Quarter 2014



# Wood County Funding Sources 2<sup>nd</sup> Quarter 2014





### Second Quarter 2014 Crisis Services






