At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices, orders and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved minutes of June 23, 30, 2014 and July 3, 7, 2014.

Robert Hinton, Jr. was sworn in as a General Services Worker at the Wood County Day Report Center.

Michael Hall was sworn in as a member of the WV Route 2 and Interstate 68 Authority.

AGENDA AND DISCUSSION ITEMS

At 9:30 A.M., the County Commission held a hearing in regard to the Michael W. Johnson estate. Robert Ellison, Attorney for Geneva Johnson, Executrix requested that Ms. Johnson be removed as Executrix and that Jason Michael Johnson be appointed as Administrator C.T.A.D.B.N. After review, the County Commission approved the request. Information in regard to this estate is on file in the Probate Office. (Probate Order)

At 9:37 A.M., the County Commission approved the hiring of John Wetzel as a Deputy Sheriff and Jason Prunty as a Holding Center Officer.

At 9:45 A.M., the County Commission held a hearing in regard to the Charles R. Byers estate. John Smith and Charlotte Westbrook, beneficiaries of the estate requested that Florence Carpenter, Executrix be removed and the Sheriff of Wood County be appointed as Administrator C.T.A.D.B.N.
