At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices, orders and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved minutes of May 5, 12, 15 and 19, 2014.

The County Commission, upon a motion duly made, seconded and passed approved Erroneous Assessment Applications in regard to real and personal property. Copies are attached.

AGENDA AND DISCUSSION ITEMS

At 9:34 A.M., the County Commission, sitting ex-officio as the Board of Canvassers, certified the election results from the Primary Election held on May 13, 2014. They adjourned as the Board of Canvassers, sine die. (Order A/certify election primary 2014)

At 9:35 A.M. Chief Deputy Shawn Graham informed the Commission that their Administrator T.R. Smith, will be retiring and he needs his salary placed into the 2014/2015 budget. The County Commission stated they will process a budget

revision at the first of July to cover Mr. Smith's salary through September first and asked Chief Graham to provide them with a revised list of duties for the position prior to Mr. Smith leaving.

At 9:48 A.M., the County Commission discussed the County Purchasing Policy. Commissioner Gainer made a motion to leave the policy as it is. The motion died from a lack of a second. Upon the recommendation of the Prosecuting Attorney, Jason Wharton, the Commission agreed to reduce the threshold amount from \$5,000.00 to \$1,500.00. A copy of Mr. Wharton's recommendation is attached to these minutes and shall be made a part thereof. (M/2807)

At 10:10 A.M., the Commission discussed dilapidated properties located at 1011 North Power Avenue, 122 Victory Street and Emerson Manor Trailer Park.

At 10:55 A.M., the Commission discussed the cleaning service. The Commission Authorized the cleaning and janitorial services for the County owned buildings to be put out to bid. (M/2808)

At 11:00 A.M., the County Commission approved the hiring of Lindsey Shawver and Tyler Lewis in the WVU Extension Office.



RE: PURCHASING POLICY

Dear Commissioners:

It is my understanding that the purchasing policy is once again on the County Commission's agenda. The current policy was adopted last May and placed into effect July 1, 2013 after a work session including the County Clerk, finance staff from the Clerk's office, the County Administrator, the staff in the Administrator's office, and a County Commissioner. I believe that the plan was well thought out and provided the necessary flexibility for the full time elected officials to carry out their Constitutional and Statutory duties during such times that the Commission is not in session.

With that said, the policy was recognized as a work in progress. From attending the meetings, it is clear that the Commission wants to exercise more control over individual expenditures. In the policy all parties agreed to establish a threshold amount of \$5,000 that would require Commission approval before a purchase order could be issued. For all other purchases, if the administrator's office found that sufficient funds were in the elected official's line item they were required to issue a purchase order.

I would be willing on behalf of my office to agree to reduce the \$5,000 threshold amount. It is rare that large purchases must be done on an immediate emergency basis and could most often await the action of the Commission. If the Commission is inclined to make any changes to the Purchasing Policy I would propose that the Commission consider reducing the \$5,000 threshold to \$1,500 and leaving the remainder of the policy intact.

As we discussed last year, it would be my suggestion to make any changes effective July 1, 2014 so that the auditor is not required to audit the county under multiple policies during one fiscal year.

I would also suggest that the current purchasing policy has worked quite well and may require no changes at all. Over the last week, I have reviewed the Prosecutor's Office budget to

project our year in position. I have shared these findings with the County Administrator. At the end of July, I currently project that my office will be able to return to the County Commission over \$12,500 from the data processing, maintenance, training, professional services, supplies, and equipment line items. This is a conservative estimate.

Additionally, in the past week, I have renegotiated our legal research plan. This has allowed our research capability to expand while reducing the monthly cost by \$127.12 over the current rate and \$178.60 over what was initially proposed as the contract rate for the upcoming year without any change in services.

In short, I believe that the flexibility that the Commission offered the elected officials in the present purchasing policy has worked for the most part and as is reflected in the expected amount to be returned from my office, has not been abused. It is important that the purchasing policy remain objective in nature with clear guidelines for the elected officials, administrator's office, and clerk's office. I hope that we are able to continue to work with the Commission in the future, in a collaborative way, as we did with the purchasing policy last year to improve the efficiency of County government and the services that we provide our citizens.

The County Administrator's office shall issue purchase orders upon the request of a purchasing department, provided that the purchasing department has adequate funds for purchases in amounts less than one thousand five hundred dollars and zero cents (\$1,500.00). Upon obtaining said purchasing order, the purchasing department may proceed with said purchase.
3. For purchases greater than one thousand five hundred dollars and zero cents (\$1,500.00), a request for a purchase order shall be made to the Wood County Administrator's Office. However, such purchases shall not be made until approved by the Wood County Commission. To encourage competition, the County Commission requests that pricing from three vendors be submitted with each proposed purchase between five thousand dollars and zero cents (\$5,000.00) and fourteen thousand nine hundred ninety-nine dollars and ninety-nine cents (\$14,999.99).
4. The County Finance Office is authorized to make payment on invoices submitted by a purchasing department that meet the following conditions:
 - (a) The invoice is less than one thousand five hundred dollars and zero cents (\$1,500.00).
 - (b) The corresponding budget line item has sufficient funds.
 - (c) The invoice does not exceed the original purchase order by more than ten percent.
5. This purchasing policy shall not apply to travel and related expenses. Said expenses shall be in compliance with the Travel Policy.
6. The use of a County Purchasing Card is recognized as a form of payment. Purchases made using the Purchasing Card shall follow the purchasing policy.


