At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices, orders and other correspondence.

The County Commission approved Erroneous Assessment Applications in regard to real and personal property. Copies are attached and shall be made a part thereof.

AGENDA AND DISCUSSION ITEMS

At 9:31 A.M., the County Commission discussed an abandoned and dilapidated property located at 221 and 231 Island View Drive. Wood County Compliance Officer, John Reed, stated he and the County Engineer, Bill Brown, will go back out and inspect the property. He also mentioned a property owned by Betty Napier that the County previously gave a thirty day time period to clean up. Mr. Reed stated he will have her served by the Sheriff's Office and give her another thirty day days.

At 9:38 A.M., the County Commission approved the hiring of Clifton Stone as a Telecommunicator with the E-911 Center.

At 9:39 A.M., Commissioner Dunn stated that Tri-C needed to be moved as soon as possible to vacate the property to be utilized by the incoming cracker plant. He provided an update on all the different leagues and what their status is.

At 9:43 A.M., the County Commission placed the name of Andy Hartleben in nomination to serve on the Wood County Solid Waste Authority. (Order A/1350)

At 9:46 A.M., the County Commission signed a Resolution supporting that the U.S. Senate consider granting the Delta Queen river boat an exemption to the Safety of Life at Seas (SOLAS) Act. This would permit them to once again carry passengers on the river. A copy of said Resolution is attached to these minutes and shall be made a part thereof.

At 9:48 A.M., the County Commission discussed a potential trail at the Wood County Veterans Park.


Having no further scheduled appointments or business to attend to, the County Commission adjourned at 10:23 A.M.

NOVEMBER 3, 2014

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

WHEREAS, the Delta Queen is an American sternwheel steamboat;

WHEREAS, the Delta Queen was initially listed on the National Register of Historic Places in 1970 and subsequently declared a National Historic Landmark in 1989;

WHEREAS, this National Historic Landmark more recently lost its exemption under the Safety Of Life At Sea Law (SOLAS) and as such is prohibited from further providing overnight passenger cruises on the Mississippi River and its tributaries and including our own Ohio River;


WHEREAS, the United States House of Representatives has passed a bill extending the Delta Queen's exemption from SOLAS and which would allow the Delta Queen to once again operate with passengers on our rivers; and

WHEREAS, it is necessary for this bill to further be approved by the United States Senate.

NOW THEREFORE BE IT RESOLVED BY THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA that it be known that the river city of Parkersburg, West Virginia supports extending the SOLAS exemption to the Delta Queen so that this majestic American National Historic Landmark may be permitted to once again ply the waters of our nation's rivers while carrying overnight passengers.

BE IT FURTHER RESOLVED that the United States House of Representatives and the United States Senate be and they are hereby encouraged to pass a bill to grant such an exemption from SOLAS to the Delta Queen in a timely fashion.
