The County Commission, upon a motion duly made, seconded and passed, approved minutes of September 4 and 8, 2014.

Tim Graham was sworn in to the Wood County Parks and Recreation Commission (Mountwood Park) on August 18, 2014. The oath of office was put on record today.

At 9:57 A.M., the County Commission approved the hiring of James Dixon IV, Timothy Gilson and Tara Hodge for the Day Report Center.

At 10:02 A.M., the County Commission met with Hernando Escandon and Quyen Nguyen from the Wood County Day Report Center to discuss the Community Corrections Program. Mr. Escandon stated it was important for them to be able to track the Community Corrections Grant. The Commission asked the County Clerk to provide Ms. Nguyen with a read only access to the County budget system so she can obtain financials for the Center.

At 10:27 A.M., the County Commission went into Executive Session under WV Code Chapter 6, Article 9A-4 of 1931, attorney/client privilege. Also in attendance with the Commissioners was Marty Seuffer, County Administrator and Jason Wharton, Prosecuting Attorney.
