# ORDINANCE IMPOSING FRANCHISE FEE UPON CABLE TELEVISION OPERATORS

Pursuant to the provisions of Section 622 of the Cable Communications Act of 1984, the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, is authorized to impose upon cable television operators a franchise fee of no more than five (5%) percent upon Gross Revenue. The imposition of such a franchise fee was further authorized in Franchise Agreements granted to CEBRIDGE ACQUISITION LLC d/b/a SUDDENLINK COMMUNICATIONS and COMMUNITY ANTENNA SERVICE, INC.

Accordingly, it is hereby ordained by the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, that a franchise fee of five (5%) percent of Gross Revenue is hereby imposed upon CEBRIDGE ACQUISITION LLC d/b/a SUDDENLINK COMMUNICATIONS, COMMUNITY ANTENNA SERVICE, INC. and any other operator or provider of cable television service to residents of unincorporated areas of Wood County, West Virginia.

For the purpose of this Ordinance, "Gross Revenue" shall mean any revenue derived from customers in the unincorporated areas of Wood County, West Virginia, as determined in accordance with generally accepted accounting principles, received by the franchisee or cable operator directly from subscribers for the operation of the cable system to provide cable services in the unincorporated areas of Wood County, West Virginia; provided, however, that such fees shall not include any taxes, fees or assessments of general applicability collected by the franchisee or cable operator from subscribers for pass through to a government agency, including the franchise fee herein imposed, FCC User Fees, unrecovered bad debt, credits, refunds and deposits paid to subscribers and any PEG or I-Net amounts recovered from subscribers. The effective date of this Ordinance shall be November 1, 2015.

Pursuant to the provisions of Section 622 of the Cable Communications Act of 1984, the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, is authorized to impose upon cable television operators a franchise fee of no more than three (3%) percent upon Gross Revenue. The imposition of such a franchise fee was further authorized in Franchise Agreements granted to CEBRIDGE ACQUISITION LLC d/b/a SUDDENLINK COMMUNICATIONS and COMMUNITY ANTENNA SERVICE, INC.

Accordingly, it is hereby ordained by the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, that a franchise fee of three (3%) percent of Gross Revenue is hereby imposed upon CEBRIDGE ACQUISITION LLC d/b/a SUDDENLINK COMMUNICATIONS, COMMUNITY ANTENNA SERVICE, INC. and any other operator or provider of cable television service to residents of unincorporated areas of Wood County, West Virginia.

For the purpose of this Ordinance, "Gross Revenue" shall mean any revenue derived from customers in the unincorporated areas of Wood County, West Virginia, as determined in accordance with generally accepted accounting principles, received by the franchisee or cable operator directly from subscribers for the operation of the cable system to provide cable services in the unincorporated areas of Wood County, West Virginia; provided, however, that such fees shall not include any taxes, fees or assessments of general applicability collected by the franchisee or cable operator from subscribers for pass through to a government agency, including the franchise fee herein imposed, FCC User Fees, unrecovered bad debt, credits, refunds and deposits paid to subscribers and any PEG or I-Net amounts recovered from subscribers. The effective date of this Ordinance shall be November 1, 2015.
