At 9:35 A.M., the County Commission announced vacancies on the Wood County Development Authority. Commissioner Tebay stated he will talk to Chad Mildren, Director, to obtain their recommendations to fill out the remainder of the Board.

3. That in my opinion the ends of public justice require said accused to be brought to

this State for trial at the public expense, and I believe I have sufficient evidence to secure the

conviction of said accused of said crimes.

4. That this request is made in good faith and not for the purpose of collecting a debt

or for any private purpose whatever, and if the requisition now applied for be granted, criminal

proceedings shall not be used for any of said objects.

5. That no former application for a requisition for said accused, growing out of the

same transaction, has been made.

I annex hereto a certified copy of the Criminal Complaint against him with affidavit to the

facts thereof by a person having actual knowledge thereof.

(Criminal Complaint Continued) drifting over into RDW's lane. RDW had to move off of the roadway to avoid colliding with the truck. RDW turned around and could see BAP initiate a traffic stop with the Ranger on Frontage Rd. The truck continued about .25 miles before pulling into the Pifer's Service Station parking lot located at 115 Elizabeth Pike, Mineral Wells, Wood County, WV. RDW walked up to the driver's door and immediately noticed the strong odor of an alcoholic beverage coming from inside the vehicle. The driver identified himself as David Francis Toncray and admitted that his license was revoked for OVI. RDW could smell the odor of an alcoholic beverage coming from Toncray's breath when he spoke. Toncray had slow, slurred speech and bloodshot, glossy eyes. Toncray admitted to having a couple of beers. Toncray exited the truck and performed the three structured field sobriety tests: The gaze nystagmus, walk and turn and the one leg stand. Toncray failed all three tests. Toncray also failed a PBT with a reading of .219. RDW placed Toncray under arrest for DUI and transported him to the Wood County Holding Facility for processing. While at the holding facility, Toncray gave a breath sample into the Intoximeter with a reading of .191. Toncray was convicted of OVI in Marietta Municipal Court on 11-04-11 and his OH driver's license is currently revoked for that conviction.
