The County Commission, upon a motion duly made, seconded and passed, approved Erroneous Assessment Applications in regard to personal property. Copies are attached to these minutes and shall be made a part thereof.

AGENDA AND DISCUSSION ITEMS

At 9:30 A.M., the County Commission discussed the bid that received late for asphalt work. Ed Hupp, Wood County Emergency Management Director, recommended the one bid be sent back unopened since he felt the bid specs were not as specific as they needed to be. The County Commission voted to reject the bid for asphalt without opening. (Order A/1522)

At 9:33 A.M., no bids were received for the radio equipment. The County Commission authorized it to be rebid. (Order A/1523)

At 9:34 A.M., Commissioner Couch questioned why wrecking companies are charging a coordinator fee when receiving a tow through 9-1-1. Director Rick Woodyard stated the Public Service Commission allows this fee to be assessed.

At 9:38 A.M., the wrecker company that potentially was to be removed from the rotation sent a letter and removed himself from the rotation.

At 9:40 A.M., Mark Rhodes, County Clerk, discussed proposed voting location changes for Precincts 8 and 75. (Order A/1524)

At 9:43 A.M., the County Commission approved Hannah Fisher and Victoria Galyean as interns for the Wood County Prosecuting Attorney's Office.

At 9:53 A.M., Assessor Rich Shaffer announced he is not planning to seek re-election to office.

At 9:59 A.M., Stacey Fleak from the Compliance Office discussed two properties with the Commission. Mrs. Fleak discussed property located on Coolidge Street and Hill Street. After discussion, the County Commission stated the Coolidge Street property will be put out for sale by sealed bids and that Attorney Vance Golden be paid legal fees in regard to the filing of a civil suit in Circuit Court. Mrs. Fleak also discussed the payment for the redemption of property taxes to Mr. Golden. The County Commission approved both payments.


