He suggested they purchase our vehicles. Commissioner Tebay asked Mr. Johnson to approach the Sheriff about him paying for an additional vehicle out of his funds. The County Commission authorized the purchase of four vehicles. (Order M/3348)

At 10:30 A.M., the County Commission met with Toni Oliver. Ms. Oliver updated them on the Sumner School museum. She stated the Sumnerite group is still meeting but have not been active as usual due to a gas leak in the building.

At 11:01 A.M., the County Commission appointed Stacey Fleak as the Floodplain Manager and Rick Woodyard as the Wood County Emergency Services Director. (Orders M/3347 and M/3346)

The County Commission placed Shane King in nomination for the Wood County Alternative Transportation System Council. (Order A/1597)
