Re: Parkersburg Country Club

Gentlemen:

This writing is submitted to request a variance to allow the placement of West Virginia Lottery gaming machines within the premises of the Parkersburg Country Club. We are fully aware of the restrictions and understand we do not comply without the requested variance. This writing outlines why we believe the restrictions should be waived.

There have been numerous requests from our members for several years to add machines in the Club. Extensive research was conducted with clubs throughout the State to understand what was involved, what pros and cons existed and what the impact was on the membership. Similarly situated clubs have chosen this as a reasonable means of providing additional funding in an effort to keep dues to a more acceptable level. Additionally, meetings were held with Club members active in the gaming machine industry to better understand the process and operation. The decision to add the machines was not made lightly and is tightly constrained. The "machine room" will be out of the way, hidden from view of the public, will be open to members and their guests only, will be operated only when the Club is normally open, with an overall goal of "if you don't know where to look, you won't know they are there".

The Club believes that the restrictions regarding distances from residential neighborhoods, etc., were intended to protect the adjoining neighborhoods. There is nothing in our plan that will have any impact on the adjoining neighborhoods. There will be no additional traffic since it is restricted to members. There will be no exterior signage to affect the attractiveness of the area. The Club hours will remain as they are today and will not be expanded for this function. From the exterior, there will be no affect, of any kind, on the appearance, traffic, noise level, lighting or any matter that could conceivably affect any adjoining neighbor.

Many members of the club have and continue to enjoy gaming machines as one of their entertainment choices and will continue to indulge whether the machines happen to be available at the Club. To those members, the installation of the machines in the controlled environment will become a "value added service" to said members without additional or incremental cost to the club or its membership.

Like the state and counties who benefit from the budget assistance provided by this legal institution, private entities should not be deprived of the same opportunity when a duly elected governing body completes its due diligence and renders a decision based on the facts after considering the impact on the surrounding community.

Within any organization, as is the case with the Club, there are those members who are opposed to having the machines based on moral grounds. That should not be a consideration for this decision, since the decision to allow machines was passed by the Legislature. Others will say that it takes away from the "family atmosphere" they want in a private club. Nothing could be farther from the truth in that every effort is made to make the room essentially non-existent unless you go looking for it. The decision to add the machines to the Club was made by the duly elected Board of Governors after consideration of all consequences. Without exception, every objection to the placement of machines in the Club is not pertinent to your decision to waive the distance requirements.

Based on the facts stated above, we respectfully request a waiver of the placement restrictions and that you allow the request to the West Virginia Lottery Commission to proceed.
