WHEREAS, Dan Carder was named by Time Magazine as one of the 100 Most Influential People in the World; and

WHEREAS, Dan Carder, son of Helen Carder and the late Dick Carder, is a native of Mineral Wells, West Virginia, having attended Parkersburg South High School, holds a bachelor's and master's degree from West Virginia University's Statler College of Engineering, and has completed his requirements for his Ph.D.
