At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved minutes of September 8, 2016.

AGENDA AND DISCUSSION ITEMS

At 9:30 A.M., the County Commission met with Bob Enoch from the Wood County Historical Society. Mr. Enoch updated them on the Phelps-Tavener House. He requested a "Spirit of Wood County" award for Paul Bibbee, who has been instrumental in researching the house. He stated he would like the Commission to visit the house and present the award there.

At 9:35 A.M., the County Commission met with representatives from Claywood Park Public Service District to begin discussions related to a requested sewer rate increase.

Commissioner Gainer stated it was poor timing to ask for a rate increase. Commissioner Couch asked that they bring some numbers to the Commission and also stated he did not believe the Commission would be in favor of any increase prior to the vote on the Wood County Board of Education bond levy that will be on the General Election ballot in November.

At 10:03 A.M., the County Commission met with Brooke Albright from the West Virginia Attorney General's Office. They discussed a program they are involved in regarding the substance abuse problem in the state.

At 10:18 A.M., the County Commission discuss the jail bill. Carole Jones, Circuit Clerk, was originally scheduled to be at the meeting, but was unable to attend due to personal reason. Prosecuting Attorney, Jason Wharton, discussed the issue with the Commission. Mr. Wharton stated the recent grand jury had many people who were in custody at the Regional Jail.

At 10:27 A.M., the County Commission went into Executive Session to discuss a personnel issue. Also in attendance were Matt Smith, Chief Deputy of the Sheriff's Department, Steve Stephens, Director of the Wood County Holding Center, Jason Wharton, Prosecuting Attorney and Marty Seuffer, County Administrator. They adjourned at 10:52 A.M. Order M/3476)

At 11:00 A.M., the County Commission asked to have the Wood County Chief Tax Deputy, Bob Tranquill, appear at the next scheduled meeting to discuss a large invoice they received from CSSI to process the tax bills.

WHAT ARE OPIOIDS?

Opioids are a powerful and addictive type of prescription painkiller that have similar chemical properties and addiction risks as heroin. While opioids may provide temporary relief, they do nothing to address the underlying injury and can have serious side effects.

These drugs may lead to: dependence, tolerance, accidental overdose, coma and death.

The most common prescribed opioid painkillers in West Virginia are:

- Oxycodone (OxyContin)
- Hydrocodone (Lortab and Vicodin)

HOW TO PROTECT YOUR CHILD

- Talk to your healthcare provider about alternative pain management treatment options (see below).

First-time prescription opioid users have a 64% higher risk of early death than patients who use alternative pain medication.

- If your child is prescribed an opioid painkiller, talk about the dangers of misusing medication, including overuse and medication sharing.
- Monitor your child's intake of prescription medication to ensure he/she is following dosage instructions.
- Safely dispose of any unused medication through a prescription drug drop box or a DEA Take-Back program.
