INDUCEMENT RESOLUTION OF THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, APPROVING IN CONCEPT THE REFUNDING OF THE WOOD COUNTY BUILDING COMMISSION (WEST VIRGINIA) TAXABLE LEASE REVENUE BONDS, SERIES 2010 A (RECOVERY ZONE ECONOMIC AND DEVELOPMENT BONDS) DATED AS OF DECEMBER 22, 2010, AND APPROVING IN CONCEPT CERTAIN RELATED ACTIONS, DECISIONS AND PROCEEDINGS, INCLUDING THE SCHEDULING OF A FIRST READING OF A PROPOSED ORDINANCE AND PUBLIC HEARING OF THIS COMMISSION RELATING THERETO.

WHEREAS, the Wood County Building Commission (the "Building Commission") in 2010 issued its \$6,490,000 Taxable Lease Revenue Bonds, Series 2010 A (Recovery Zone Economic Development Bonds), of which \$5,055,000 principal par amount remains outstanding (the "Outstanding Bonds") and its \$95,000 Lease Revenue Bonds, Series 2010 B (Tax Exempt- Bank Qualified Bonds), which have been paid in full and retired, all in order to finance the Judicial Center project for the County Commission of Wood County (the "County Commission"); and

WHEREAS, the County Commission and the Building Commission have been advised that debt service savings can be achieved by the refunding of the Outstanding Bonds through the issuance of one or more series of refunding bonds by the Building Commission (the "Refunding Bonds"); and

WHEREAS, the County Commission desires to approve in concept the proposed refunding of one or more series of the Outstanding Bonds through the issuance of one or more series of Refunding Bonds by the Building Commission, the issuance of the Refunding Bonds to be contingent upon the final approval by the County Commission and its legal counsel, Dan A. Marshall, Esquire, of the various documents relating to the issuance of the Refunding Bonds and the final terms and provisions thereof; and

WHEREAS, the County Commission desires to authorize the taking of actions in connection with such refunding, including without limitation the scheduling of a first reading of a proposed ordinance and public hearing of this Commission and requesting that the Building Commission enact and adopt all necessary ordinances and resolutions relating to the issuance of the Refunding Bonds by the Building Commission.

NOW, THEREFORE, BE IT ORDERED, That the County Commission approves in concept the refunding of one or more series of the Outstanding Bonds and the issuance of one or more series of Refunding Bonds by the Building Commission; and

BE IT FURTHER ORDERED, That the Commissioners, Administrative and Operations Officers/Office of County Administrator, Legal Counsel and Underwriter, Bond

Counsel and Issuer's Counsel hereafter designated, as well as all other employees of the County Commission, are authorized to move forward with the refunding and (in connection therewith) to (a) prepare for the County Commission's consideration, adoption and enactment such ordinances and resolutions of the County Commission as may be necessary to proceed with the issuance of the Refunding Bonds and the refunding of one or more series of the Outstanding Bonds, to schedule a first reading of a proposed ordinance and public hearing relating thereto, and (b) request the Building Commission to enact and adopt such ordinances and resolutions as may be necessary to proceed with the issuance of the Refunding Bonds and the refunding of one or more series of the Outstanding Bonds, to schedule a first reading of a proposed ordinance and public hearing relating thereto; and

BE IT FURTHER ORDERED, That Crews & Associates, Inc. is hereby approved as the Underwriter with respect to the proposed issuance of the Refunding Bonds, the fees and expenses of such Underwriter and its counsel to be paid from the proceeds of the Refunding Bonds; and

BE IT FURTHER ORDERED, That Bowles Rice LLP is hereby approved Bond Counsel to prepare all documents with respect to the proposed issuance of the Refunding Bonds, the fees and expenses of such Bond Counsel to be paid from the proceeds of the Refunding Bonds; and

BE IT FURTHER ORDERED, That Bowles Rice LLP is hereby approved Issuer's Counsel to prepare and review all documents with respect to the proposed issuance of the Refunding Bonds, the fees and expense of such Issuer's Counsel to be paid from the proceeds of the Refunding Bonds; and

BE IT FURTHER ORDERED, That execution and delivery of the documents relating to the Refunding Bonds to which the County Commission is a party may be approved by further order of the County Commission contingent upon the approval of the forms of the various documents and the final terms and provisions thereof by the County Commission and its legal counsel, Dan A. Marshall, Esquire, who is hereby ratified, approved and confirmed as legal counsel for the County Commission in this matter.





PROGRAM AWARD**

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made and entered into this 21st day of August, 2017, by and between the City of Parkersburg, hereinafter referred to as the City and the County Commission of Wood, hereinafter referred to as the County, both of Wood County, State of West Virginia, witnessed:

WHEREAS, this MOU is made under the authority of Chapter 7-1-3 and Chapter 8-1-7 of the West Virginia State Code; and

WHEREAS, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this MOU is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this MOU; and

WHEREAS, the City agrees to provide the County \$12,681 from the JAG award for the Wood County Sheriff's Department and the CITY will receive \$17,975 from the JAG award for the Parkersburg Police Department; and

WHEREAS, the City and County believe it to be in their best interests to reallocate the JAG funds.

NOW THEREFORE, the COUNTY and CITY agree as follows:

Section 1.

City agrees to pay County a total of \$12,681 of JAG funds.

Section 2.

County agrees to use \$12,681 for the Wood County Sherriff Department by September 30, 2019. Sheriff's Department will purchase items listed in application submitted to the Bureau of Justice Assistance.

Section 3.

Nothing in the performance of this Agreement shall impose any liability for claims against County other than claims for which liability may be imposed by the West Virginia Tort Claims Act.

Section 4.

Nothing in the performance of this MOU shall impose any liability for claims against City other than claims for which liability may be imposed by the West Virginia Tort Claims Act.

Section 5.

Each party to this MOU will be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

Section 6.

The parties to this MOU do not intend for any third party to obtain a right by virtue of this Agreement.

Section 7.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.

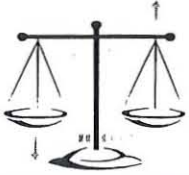
