#### CONCERN: Lockhart Property on Drain Road

Actions: Letters/Signatures of area property owners, Frequent calls to code enforcement and solid waste. previous meetings with county commissioners, Lockhart family hearing before the Commissioners.

Results: Property cleanup on the back parcel occupied by Marlene Landis. No results on the property of CONCERN occupied by Terry and Elaine Allman and directly on Drain Road and visible to every landowner on the road.

These photographs show INACTIVITY on property occupied by Terry Allman.

Although back parcel occupied by Marlene Landis has changed with all work done on Marlene's property has been done by sister, Jane Horton and her husband. The work that has been done has •been clearing of brush which exposes the debris more. Jane said that although she is an heir and responsible for the cleanup, when they tried to mow or pick up trash on the land occupied by Terry, they were met with harsh threats. She expressed fear of Terry.

Terry refuses to let people clean/mow and will not do it himself. When the county visits him, it gets worse afterwards, with him stacking more trash in the most visible spot.

Dogs are still ill cared for and now producing puppies Pallet fence enclosure next to the road is full of junk/trash Two carports full of trash Multiple vehicles, tires, trash, wood stacked around house Junk house trailer with trash around it

Pattern of this family: This is the second residence that Marlene has had the county involved with. County documents (Book 1106 page 492) show that 1405 4<sup>th</sup> Ave, a lien was placed for the cost of demolition \$4,675. Then Popcorn Properties purchased it after she let the taxes go delinquent.

The community is the victim here, not Terry and company, as they want to appear to the county. There are ordinances in place that should be protecting the people of this community. A hearing was in good <sup>°</sup>faith, yet no changes to Terry's property. Letters, calls, visits from code enforcement....several years of virtually, no results. Homeowners considering selling for much less than property is worth. A great frustration that county officials seem to not have any power with Terry.

Now with the Economic Development focusing on this area because of Hino, our county officials need to be proactive with the Lockhart property. This one eyesore is defining the rest of our property. Now is the time to apply the fines and pressure. These photographs show that the problem with Terry is unchanged. Our community deserves better.


