THIS AGREEMENT, entered into this ______, 20___, by and between the WEST VIRGINIA DEPARTMENT OF MILITARY AFFAIRS AND PUBLIC SAFTEY, DIVISION OF CORRECTIONS, a State agency, hereinafter referred to as "Corrections", party of the first part, and the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, , hereinafter referred to as "County", party of the second part:

WHEREAS, Corrections is an agency of the State of West Virginia duly established and empowered under the provisions of Chapter 25, of the Official Code of West Virginia, 1931, as amended, to manage, direct, control and govern the penal and correctional institutions placed by law under its control; and

WHEREAS, County is a County Commission established and empowered by Chapter 7, of the Official Code of West Virginia, 1931, as amended, to manage, direct, control and govern the county; and

WHEREAS, Corrections and County have mutual needs in assuring that jail inmates are held in appropriate manner and facilities, for the safety of the general public. And,

WHEREAS, County is operating a holding facility that it can no longer staff, due to rising costs. And,

WHEREAS, the jail facilities are overcrowded, and adding to the burden on an already overcrowded situation would not be in the best interest of the public. And,

WHEREAS, Corrections and County would benefit mutually in the State assisting in staffing the holding facility. And

WHEREAS, both Corrections and County are desirous of entering into an agreement whereby Corrections staff's the Wood County Holding Facility.

liens, judgments, damages, losses and expenses including reasonable legal fees and costs arising in whole or in part and in any manner from acts, omissions, breach or default of the opposite agency, its officers, employees, subcontractors, and agents during the receiving agency's supervision of the sending agency's requested employees.

- 7. The initial term of this agreement will be for a twelve (12) month period beginning on the date of execution by both parties, and shall continue in force and be automatically renewed for such succeeding twelve (12) month periods as is deemed agreeable and beneficial to both parties.
- This agreement may be cancelled at any time by either party after having provided a thirty (30) day written notice to the other party.
- 9. The day to day functions of operating the facility, and directing employee assignments and work shall be the responsibility of the County, and Corrections shall handle the supervisory issues of discipline, oversight, and all other administrative functions.
