He stated American Tower intends to continue the lease for an additional ten (10) years or they would be willing to pay an upfront cost of \$20,000.00 for an additional twenty (20) years on the lease. The County Commission agreed to allow them to continue the lease and at the end of the ten (10) year period on a month to month lease at a much higher rate.

At 10:36 A.M., Chris Whitaker, Wood County IT Director, met with the County Commission to request a purchase for a replacement backup server for the county computer system. The County Commission approved the purchase.

At 10:47 A.M., the County Commission, upon a motion duly made, seconded and passed, awarded the bid for financing vehicles for the Sheriff's Department to United Bank for a five (5) year period of time. (Order M/3910)

At 10:50 A.M., the County Commission, upon a motion duly made, seconded and passed, certified the Primary Election results. (Order A/certifyelectionPrim2018)
