Colombo and made unanimous by David Blair Couch, having ascertained that the net amount to be raised by the Levy of Taxes for the Current Year for the General County Fund purposes will be thirteen million one thousand four hundred twenty-five dollars and 00/100ths cents (\$13,001,425.00) for the Current according to the estimate and entered of record on the 28th day of March, 2019. Said estimate having been published as required by law, and no one appearing to oppose this Commission or to take exception thereto, and the Office of the State Auditor, Chief Inspection Division, having heretofore by a letter received by this Commission dated April 2, 2019 giving Notice Approval of the Levy Estimate as submitted, it is therefore ORDERED that said Estimate and Rate of Levy proposed therein, be approved and the following levies be laid on each One Hundred Dollars valuation of each class of Property:

13.64 of Class I Property

27.28 of Class II Property

54.56 of Class III Property

54.56 of Class IV Property

Furthermore, the Commission has ascertained that the net amount to be raised by the Excess Levy of Taxes for the use of the Wood County/Parkersburg Libraries as approved by the voters of Wood County during the May 10, 2016 election will be five-hundred twenty-six thousand one-hundred eighty-one dollars and 00/100th cent (\$526,181.00). It is therefore ORDERED that said Estimate and Rate Levy proposed therein, be approved and the following levies be laid on each One Hundred Dollars valuation of each class of Property:

- .54 of Class I Property
- 1.08 of Class II Property
- 2.16 of Class III Property
- 2.16 of Class IV Property

For the purpose of the aforesaid, being based upon the raised assessment thereon, the Levy Order and the Levy Rate Sheets are attached to this Order and should be made a part thereof. (Order A/LevyOrder2020)

- 2.16 of Class IV Property




