At 9:30 A.M., the County Commission held a hearing in regard to the Matthew D. Parker estate. Lea Parker requested that Don Parker, Administrator, be removed. The County Commission, upon a motion duly made, seconded and passed, awarded the bid to the sole vendor, Miller Communications, pending approval of the Sheriff. (Order A/2090)

At 10:45 A.M. the County Commission held a hearing in regard to the Gary Cunningham estate. Denise Schuck, Chief Tax Deputy, was present. After review, the County Commission Ordered that the Charlotte Winters is responsible for payment of two claims, that Charlotte Winters issue payment and obtain releases to be filed with the County Clerk thirty days from the date of service of this Order. At 11:00 A.M., the County Commission held a hearing in regard to the Connie Linder estate. Don M. Linder, Executor, asked that a claim be disallowed. After review, the County Commission Ordered that said claim be disallowed. (Probate Order)


