



## RESOLUTION

**WHEREAS**, the State of West Virginia has been sub-divided into seven local Workforce Areas in order to implement the policies and objectives of the Workforce Innovation and Opportunity Act of 2014 (WIOA); and,

**WHEREAS**, the primary responsibility for implementing the policies and objectives of the WIOA act is the board composed of "Locally Elected Officials" (known informally as the "LEO"); and,

**WHEREAS**, pursuant to the WIOA act and state policy, a "Locally Elected Official" has been defined as one county commissioner from each of the state's fifty-five counties as well as mayors of municipalities meeting a population threshold of 10,000 residents; and,




**WHEREAS**, for the purpose of administration, fiscal responsibility and the efficient delivery of services, the Region 4 LEO has created and operates under the Mid-Ohio Valley Workforce Investment Corporation (MOVWIC), a non-profit entity organized under West Virginia statutes.
