At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved minutes of January 7 and 10, 2019.

**AGENDA AND DISCUSSION ITEMS**

At 9:30 A.M., Blaine Myers, Attorney asked that the hearing for the Carrie Stewart estate be continued generally. (Probate Order)

At 9:45 A.M., James Wright failed to show for a hearing in regard to the Tanya Wright estate. (Probate Order)

At 10:15 A.M., the County Commission held a hearing in regard to the Leroy King estate. Valerie Mace, Executor, asked that claims be disallowed. After brief discussion, the County Commission disallowed the claims. (Probate Order)

At 10:30 A.M., the County Commission held hearing in regard to the David McCashe estate. Tasha Miller requested the County Commission remove Donna McCashe as Executrix.

After discussion, the County Commission moved that Donna McCashe be removed as Executrix and that Tasha Miller be appointed as Administratrix CTA. (Probate Order)

The County Commission met with Sarah Farnsworth, Compliance Officer. Ms. Farnsworth gave an update on abandoned and dilapidated properties. They first discussed 2440 Blennerhassett Heights, Parkersburg, WV. Ms. Farnsworth stated they have cleaned up the property.

They then discussed 720 Hill Street. The burned structure is still on the property. She hand delivered a letter to the owner and he hasn't replied. The County Commission, upon a motion duly made, seconded and passed, Ordered that bids be let for the demolition and cleanup of said property. (Order A/2080)

Next discussed was 1804 Club Drive. Ms. Farnsworth stated the property owner, A.S.N.F, LLC, has still not cleaned up the property. After discussion, it is Ordered that they be given a 90 day period for the clean up. (Order A/2081)

Ms. Farnsworth stated 157 Larkmead Road and 286 Drain Road have been cleaned up.

The County Commission set the dates for the Board of Review and Equalization. (Order A/2077)

The County Commission of Wood County, upon a motion made by James E. Colombo, seconded by Robert K. New terms will expire December 31, 2020. On the same motion, the County Commission appointed Barbara Holtz (Mid-Ohio Valley Health Department) and Patricia Stutler (Mid-Ohio Valley Health Department). Their terms will expire December 31, 2019. (Order A/2078) The oaths of Patricia Stutler, Michael Pifer, Rick Woodyard, Terry Moore, Kenneth Harris and Anthony Edwards were put on record on this date.

The County Commission approved the hiring of Sammy A. Scalise and Steven E. White as part time telecommunicators for the E-911 Center.

Having no scheduled appointments or business to attend to, the County Commission adjourned at 10:31 A.M.





Taxpayers may come before the Board of Review and Equalization January 31, February 4, 7, 14 and 21, 2019, with each session beginning at 10:00 o'clock A.M. until 12:00 Noon, and if needed, afternoon appointments from 1:00 o'clock P.M. until 3:00 o'clock P.M. on said dates and concluding at 3:00 o'clock P.M. on the 21st day of February, 2019 for the purpose of hearing any and all complaints of taxpayers as to the assessments placed upon his or her property by the Assessor. Hearings will also be available Monday, February 11, 2019 from 5:00 P.M. to 7:00 P.M. by appointment only. Appointments for all hearings must be made through the County Administrator's Office.

The County Commission shall proceed to examine and review the property books and shall add on the books, the names of persons, the value of personal property and descriptions and value of all real estate liable to assessments, which were omitted by the Assessor. They shall correct all errors in the names of persons, in the description of value of property and they shall cause to be done whatever else may be necessary to make the valuation comply with the provisions of this





Chapter; but, in no case, shall any questions of classification or taxability be considered or reviewed.

IF ANY PERSON FAILS TO APPLY FOR RELIEF IN THIS MATTER, HE/SHE SHALL HAVE WAIVED HIS/HER RIGHT TO ASK FOR CORRECTION IN HIS/HER ASSESSMENT LIST FOR THE CURRENT YEAR, AND SHALL NOT, THEREAFTER, BE PERMITTED TO QUESTION THE CORRECTNESS OF HIS/HER LIST AS FINALLY FIXED BY THE COUNTY COMMISSION, EXCEPT ON APPEAL TO THE CIRCUIT COURT.
