# 2019 Parkersburg/Wood County HOME Consortium ONE – YEAR ACTION PLAN

The City of Parkersburg/Wood County HOME Consortium's One – Year Action Plan establishes the following priorities for HOME funds during the 2019 Program Year (July 1, 2019 – June 30, 2020). The programs listed, will be the investments and specific activities to be undertaken. All funds will benefit Low to Moderate Income Households throughout Wood County.

The HOME Consortium is expected to receive \$323,902 from the U.S. Department of Housing and Urban Development in HOME Program Funds. Program Income is anticipated to be \$230,000 with a total budget of \$553,902 for housing activities in the FY 2019.

Based upon the funding anticipated, the following activities are expected to be implemented in Wood County during FY 2019:
