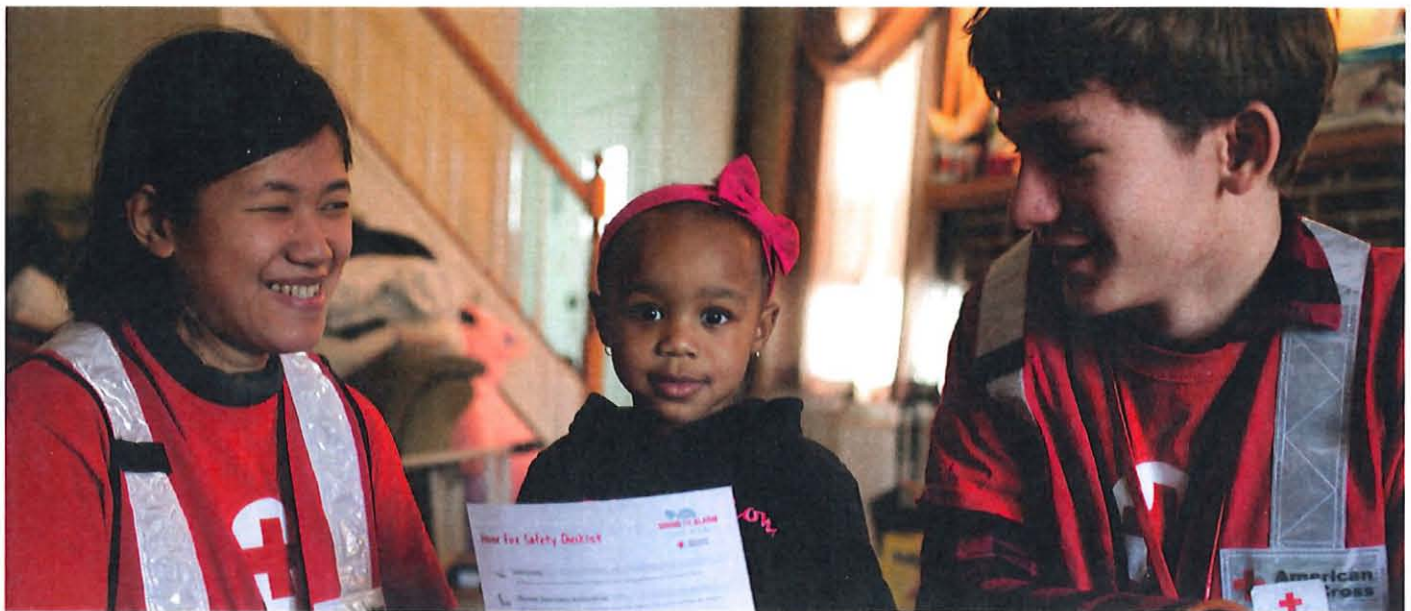

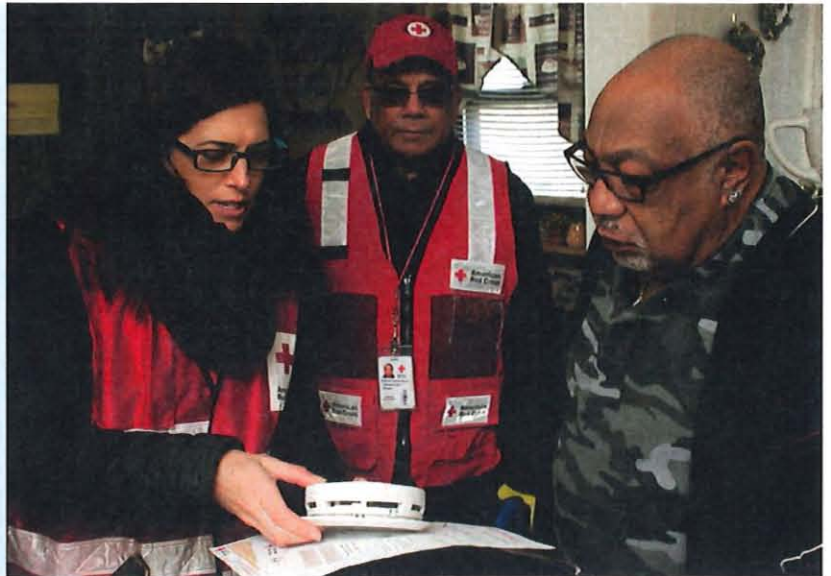

The American Red Cross has a long history of supporting generations of military members, veterans and their families. The Red Cross Hero Care App is the latest tool that provides instant access to vital Red Cross services for today's military personnel.

The Hero Care App is a mobile electronic tool that puts access to vital Red Cross services for the military and veteran communities right at their fingertips. With just a few steps military families can access assistance with both emergency and non-emergency needs.

The Hero Care App does a number of things to help both active duty members and veterans. For example, the app:

- Enables users to initiate a request for emergency services, which including the ability to generate an emergency message.

Disaster Response

The Red Cross mission is to prevent and alleviate human suffering – a work that is carried out by WV volunteers daily. In responding to almost 800 disasters last year, the Red Cross in WV provided food, shelter and comfort to individuals and families in need, as well as casework, guidance and other assistance to help survivors with recovery. All Red Cross disaster assistance is free. In West Virginia, with our deep local presence and community knowledge, we stand ready to respond alongside our partners should the need arise. Additionally, we can call on the support of Red Cross chapters nationwide for resources to help our neighbors in need following large-scale disasters. The Red Cross Service to the Armed Forces team works daily to support active duty military, veterans and families.

Home Fire Campaign

On average, 7 people die and 36 more suffer injuries each day in the U.S. due to home fires, which make up more than 90 percent of Red Cross domestic disaster responses. Research shows that working smoke alarms reduce the risk of fatalities in a home fire by 50 percent¹. The Red Cross Home Fire Campaign aims to reduce the number of fire deaths and injuries by increasing the number of working smoke alarms in at-risk communities. With generous support from donors, Red Cross volunteers and partners canvas neighborhoods to test and replace smoke alarms for free and educate families on fire prevention and safety.

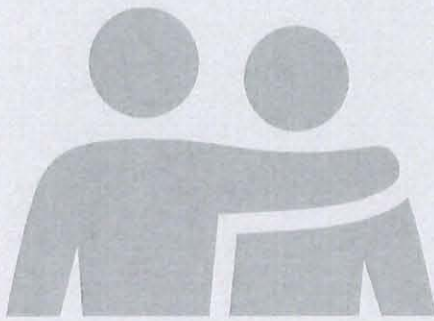

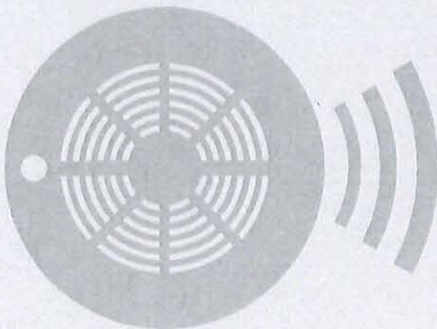

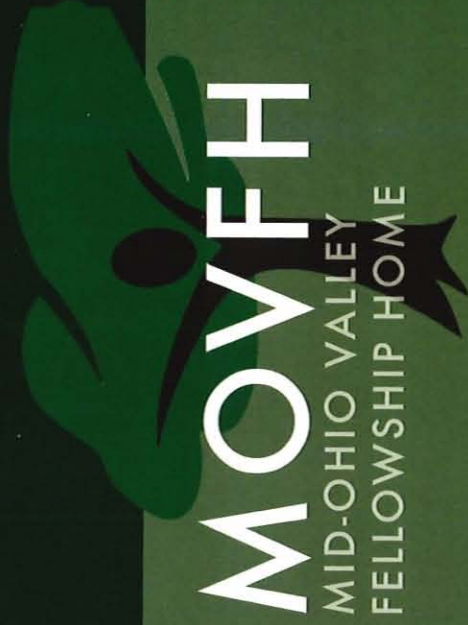

I asked for ongoing help after this treatment and went to The Mid-Ohio Valley Fellowship, a residential recovery program. I stayed six months and learned sober living skills that helped loosen the grips of addiction within my life. I have since graduated from college with a degree and career direction. I help other women in early recovery.

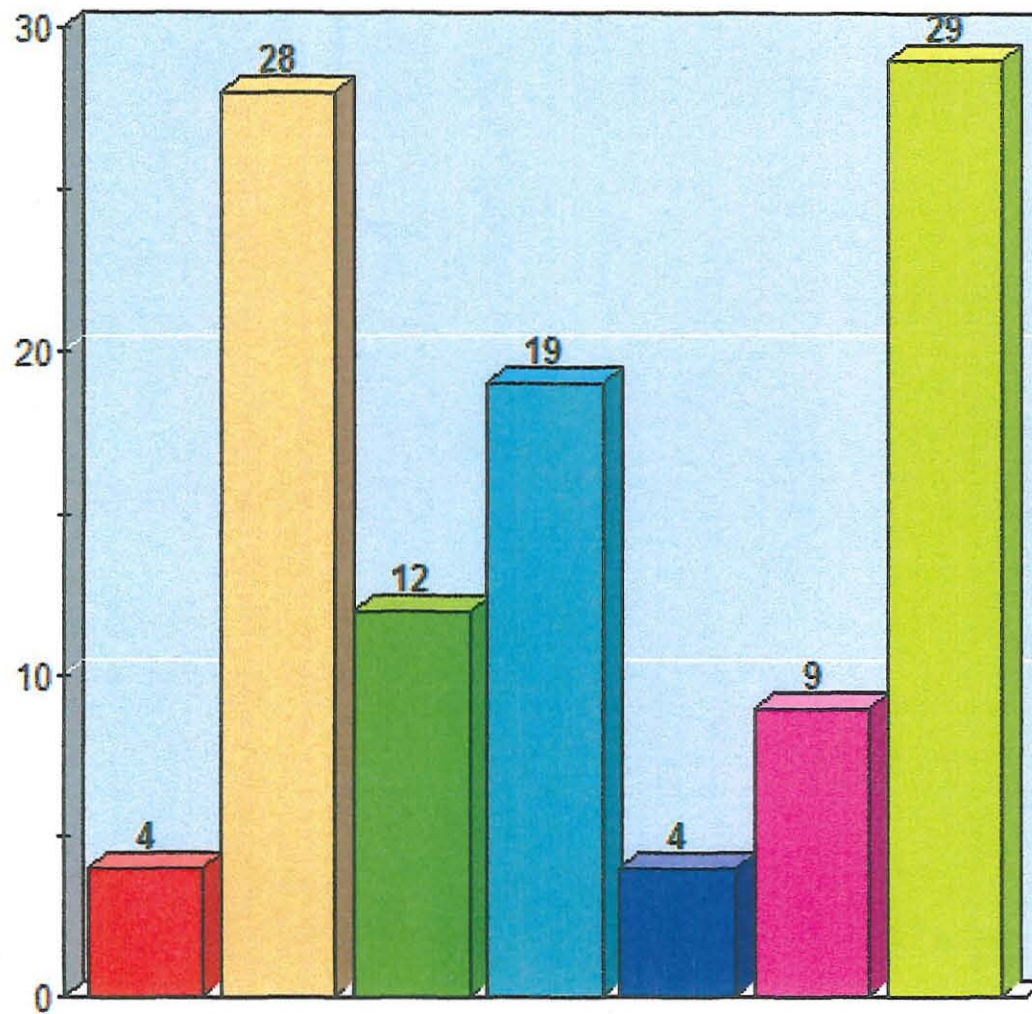

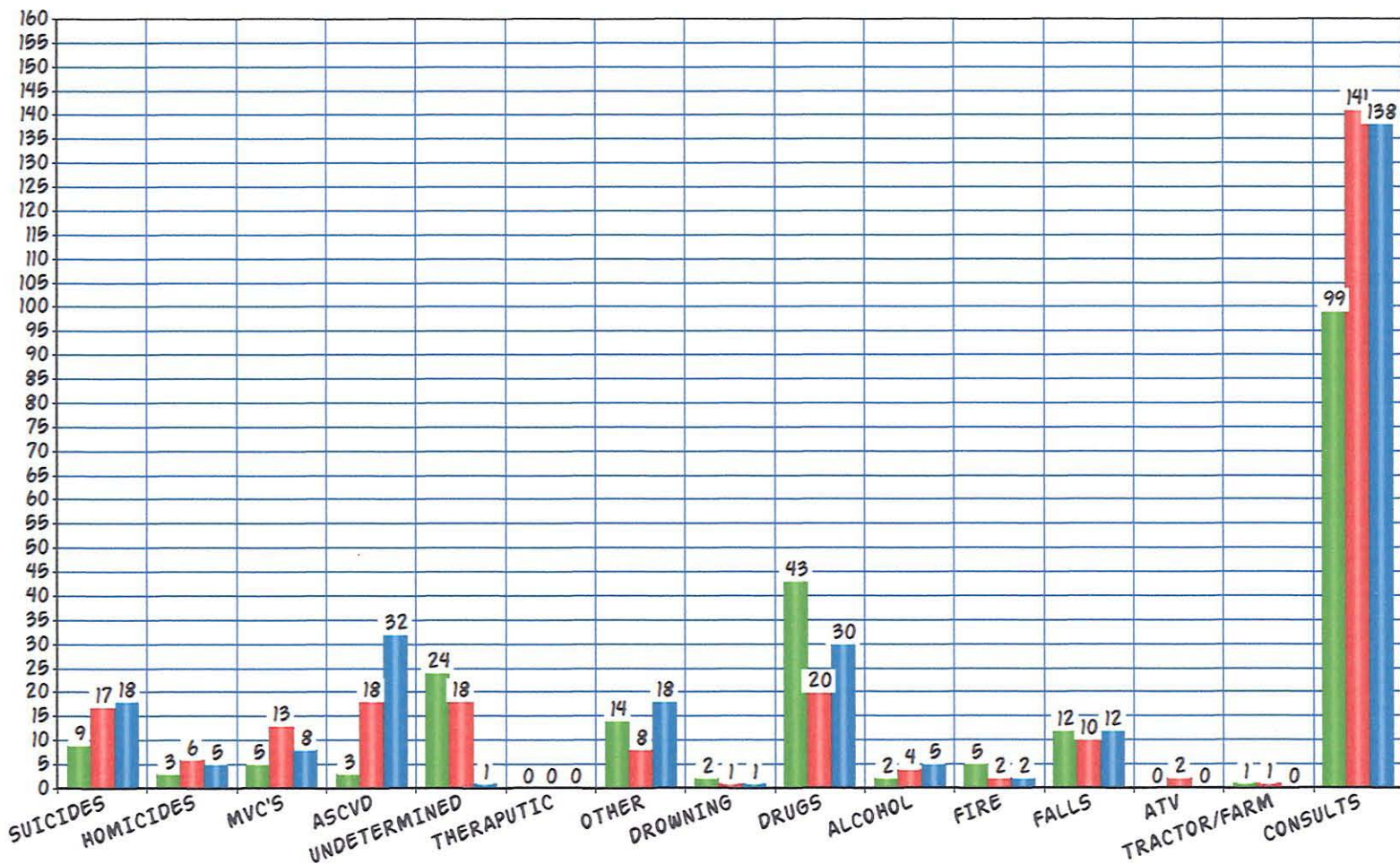
