Justice, II, Governor of the State of West Virginia, issue a requisition on the Governor of the State of Ohio for the extradition of Paula Lynne Hadley. Paula Lynne Hadley stands charged with Conspiracy, which was committed in the County of Wood, in the State of West Virginia, on or about June 13, 2020 and who is now a fugitive from justice of this State, and is now within the jurisdiction of the State of Ohio, in Washington County. The County Commission, upon a motion made by James E. Colombo, seconded by Robert Tebay and passed, authorized a Commissioner to sign the Application. Commissioner David Blair Couch abstained. (Order A/ 2275)

At 9:40 A.M., the County Commission, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, recognized Posthumously Attorney Robert T. Goldenberg for his outstanding service to Wood County, the State of West Virginia and to the United States of America. At the time of his passing, Mr. Goldenberg was the oldest practicing lawyer in the State of West Virginia. Most recently he worked with the Governor's Office of the State of West Virginia to improve response time in the State Crime Laboratory to assist in the reduction of the jail cost to counties throughout the State. Mr. Goldenberg was a friend to all and will be missed by many. (Order A/2278)

At 10:01 A.M., the County the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, announced that a vacancy exists on the Wood County Recreation Commission. Said vacancy is due to the fact that the term of Sean Andrews expires on September 15, 2020. The new term will expire September 15, 2023. The County Commission of Wood County, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. 
Having no further scheduled appointments or business to attend to, the County Commission adjourned at 10:10 A.M.
