#### Wood County Face Mask and Face Covering Policy

Adopted December 7, 2020

The Wood County Commission wants to assure you of its continued commitment to maintaining a safe and healthy workplace and that we are taking additional measures to protect you, your coworkers, and your families from the spread of COVID-19. As part of those efforts, we would like to reiterate and clarify our Face Mask and Face Covering Policy.

Please read this policy carefully.

#### The Need for Face Masks and Face Coverings

The Centers for Disease Control and Prevention (CDC) and the World Health Organization (WHO) have found that face masks and other cloth face coverings can help prevent the spread of COVID-19, especially when social or physical distancing cannot be accomplished and in areas of significant community spread.

This Face Mask and Face Covering Policy is a key part of our overall strategy and commitment to maintaining a safe and healthy workplace in light of the COVID-19 pandemic. Although knowledge about the virus and how it spreads continues to evolve, based on the information we have now, we believe these measures will help limit its spread because, among other things:

- COVID-19 is highly contagious.
- The virus generally spreads when an infected person coughs, sneezes, or talks, and respiratory droplets from their mouth or nose enter the nose or mouth of people nearby.
- A person with the virus may not have any symptoms but may still spread it.

We need your full cooperation and compliance with this and other health and safety workplace policies to make them effective.

#### When Face Masks or Cloth Face Coverings Are Required

The Wood County Commission requires that you wear a face mask or cloth face covering at all times (except when eating or drinking) when on the employer's premises. The lone exception is if you are in an individual office with no one else present in the room.

Wearing a face mask or cloth face covering is not a substitute for general hygiene and social distancing practices. All employees and visitors are encouraged to observe social distancing and frequently sanitize hands by washing or use of approved hand sanitizer.

### Acceptable Face Masks [or Face Coverings]

Disposable or "single-use"/reusable face masks may be used. If you need one, please contact the Wood County Commission Office and one will provide them to you as needed. If utilizing single use/disposable face masks, a new one must be used at the start of each workday. You may use a more protective face covering, such as an N95 surgical mask.

Alternatively, you may use your own reusable cloth face covering if it complies with the CDC recommendations and County policy. Based on current guidance, any cloth face covering must:

- Fit snugly but comfortably against the side of the face.
- Be secured with ties or ear loops.
- Include multiple layers of fabric.
- Allow for breathing without restriction.
- Be capable of being laundered and machine dried without damage or change to its shape.

Do not share your face covering[s] with any other individual.

Face coverings shall not contain any offensive, political, harassing, or discriminatory words, terms, logos, pictures, cartoons, slogans, or writing or images.

[If your face covering does not comply with this policy and all other applicable employee policies, as determined in the sole discretion of the Wood County Commission, it will provide you with a face mask for your use until you present a policy-compliant face covering.

Nothing in this policy prohibits or is intended to prevent you from exercising any protected rights including engaging in protected speech as permitted by law.

### Accommodation Requests

If you require an accommodation regarding this policy for reasons based on religion, disability, or other grounds protected by federal, state, or local laws, contact your elected official for whom you work for.

You may request the accommodation orally or in writing. You should include all relevant information, including:

- A description of the accommodation requested.
- The reason for the accommodation.

The Wood County Commission will engage in an interactive dialogue with you to determine the precise limitations of your ability to comply with this face mask policy and explore potential reasonable accommodations if required by law that could overcome those limitations. The Wood County Commission encourages employees to suggest specific reasonable accommodations. However, the Wood County Commission is not

required to make the specific accommodation requested and may provide an alternative effective accommodation, to the extent any reasonable accommodation can be made without imposing an undue hardship on the Wood County Commission.

### **Policy Modification**

Government and public health guidelines and restrictions and business and industry best practices regarding COVID-19 are changing rapidly as new information becomes available and further research is conducted. The Wood County Commission reserves the right to modify this policy at any time in its sole discretion to adapt to changing circumstances and business needs, consistent with its commitment to maintaining a safe and healthy workplace.

#### **Enforcement and Non-Retaliation**

Failure to comply with this policy may result in discipline, up to and including termination of employment. You will not be permitted on County premises if you are not in compliance with this policy.

If you witness or become aware of any employees or other individuals violating this policy, you are encouraged to immediately report them to your elected official for whom you work.

The Wood County Commission prohibits any form of discipline, reprisal, intimidation, or retaliation for reporting a violation of this policy or any other health and safety concern. Employees also have the right to report work-related injuries and illnesses, and Wood County Commission will not discharge or discriminate or otherwise retaliate against employees for reporting work-related injuries or illnesses.

### **Continued At-Will Employment**

Nothing in this policy alters the at-will nature of your employment.
