

IN RE: THE COUNTY COMMISSION ORDERED THAT THE NEW ROAD NAME REQUEST FORM FROM PAUL DAVID LAMP JR. AND MICHAEL RAY MCGEE, II BE APPROVED. THE NEW ROAD NAME WILL BE TWIN VIEW LANE.

**ORDER**

The County Commission of Wood County was in receipt of a New Road Name Request Form from Paul David Lamp, Jr and Michael Ray McGee, II, to name the road to two residences TWIN VIEW LANE. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. The road to be known as TWIN VIEW LANE is located 1.5 miles from Gihon Road on the left, Tygart Taxing District, Tax Map 160 , Parcel C. The request by Paul David Lamp, Jr. is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform, nonduplicative conversion of all rural routes to city-type addressing on a permanent basis.






