At 9:30 A.M., the County Commission discussed the proposed sewer and water rate increases for Lubeck Public Service District. The Commission agreed to set a public hearing FOR Monday, September 28, 2020 at 6:00 P .M. to take input from customers of the District.

At 9:59 A.M., Mark Rhodes, Wood County Clerk, met with the Commission. Mr. Rhodes gave a demonstration of what a voter will receive if they file an absentee ballot for the General Election in November.

At 10:14 A.M., the County Commission, upon a motion by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, approved Phase II of Apple Hill Manor Subdivision. (Order A/2288)

At 10:15 A.M., the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, reappointed Greg Arnott to the Union Williams Public Service District. (Order A/2286)

The County Commission, upon a motion made by James E. Colombo, seconded by David Blair Couch and made unanimous by Robert K. Tebay, appointed Buddy Malone and Mayor Paul Jordan to the Wood County Development Authority. (Order A/2287)

At 10:16 A.M., upon motion of David Blair Couch, seconded by James E. Colombo, and made unanimous by Robert K. Tebay, County Commissioners, upon prior adjournment of the regular session, convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Section 4, as amended. County Commissioners met with Marty Seufer, County Administrator, and Pat Lefebure, Prosecuting Attorney. All those present proceeded to discuss the matter for which the said EXECUTIVE SESSION was had, being covered by personnel matters. The Commission having concluded said discussion, the said EXECUTIVE SESSION adjourned at 10:31 o'clock A.M. (Order M/4243)

At 10:34 A.M., Rick Woodyard, Wood County E-911 Director, met with the County Commission and requested their approval to place a 50 foot pole in Fort Boreman Park to support emergency communications in the County. The County Commission approved his request and told him to move forward.


