At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion made by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, the County Commission approved Erroneous Assessment Applications in regard to real and personal property.

Carolyn Beckett took her oath as an Administrative Assistant for the Wood County Commission Office.

AGENDA AND DISCUSSION ITEMS

At 9:30 A.M, the County Commission held a hearing in regard to the Estate of Betty L. Scritchfield. Kristi Edwards and her Attorney C. Blaine Myers, were both present. Dean Furner, Administrator of the Estate was not present. After discussion, the County Commission Ordered that Dean Furner be removed as Administrator of the Estate and further Ordered that Kristi Edwards be appointed as successor Administrator. (Attorney Order)

At 9:35 A.M., a citizen addressed the County Commission to ask if they are a constitutional county. The County Commission stated they have adopted the entire constitution.

At 9:41 A.M., the County Commission met with Toni Tiano, Wood County Grant Writer and Rick Woodyard, Sheriff to discuss a COPS Grant. They requested the County participate in a COPS Grant to hire a deputy for the Sheriff's Department. The County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, did hereby AUTHORIZE participation in a Community Oriented Policing Services (COPS) Grant to hire an additional deputy for the Wood County Sheriff's Office. Said grant is in the amount of one hundred seventy-two thousand five hundred seventy-six dollars and zero cents (\$172,576.00) and is on behalf of the Wood County Sheriff's Office. (Order C/100)

Having no scheduled appointments or business to attend to, the County Commission adjourned at 10:07 A.M.





**ORDER**

On the 20<sup>th</sup> day of December 2021, came the Petitioner, KRISTI EDWARDS, in person and by counsel, C. Blaine Myers. There was no appearance by or on behalf of DEAN FURNER, Administrator of the Estate, or MARK FURNER, a beneficiary of the Estate. Petitioner appears pursuant to a Motion to Remove the Administrator.

Counsel for Petitioner advised that he has communicated by letter to Dean Furner at the address provided by Mr. Furner when he filed a prior Motion to Continue, and also published a Legal Notice of the date and time of this hearing. An affidavit reflecting of publication of the Legal Notice is filed as an exhibit.

Based upon the representations of the Petitioner, and the failure of the Administrator to file an appraisal in a timely manner as required by law, it is hereby ORDERED that Dean Furner be and is hereby removed as Administrator of the Estate of BETTY LUCILLE SCRITCHFIELD, deceased.

It is further ORDERED that KRISTI EDWARDS be and is hereby appointed as successor Administrator of the Estate of BETTY LUCILLE SCRITCHFIELD, deceased, and she shall be required to post bond, with surety, in the amount of \$25,000.00.


It is further ORDERED that RLI Insurance Company, which previously posted a surety bond on behalf of Dean Furner as Administrator, shall not be released until such time as it can be ascertained that the assets of the Estate of the decedent have not been depleted.

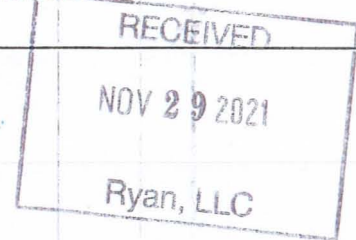




